Subject: Comments of Stakeholders on the draft Inter-se Seniority of Economic Investigators in DME0 between direct recruits and promotees-reg.

The undersigned is directed to share the draft inter-se seniority of Economic Investigators in DME0 for comments/suggestions/feedback of the concerned stakeholders. The draft inter-se seniority is placed at **Annexure 1.**

2. The draft inter-se seniority of Economic Investigators between direct recruits and promotees is prepared based on recruitment year adhering to the instruction issued by Department of Personnel and Training (DoPT) vide OM No. 2001 1/2/2019-Estt. (D) dated 13.08.2021 and O.Ms. dated 7.2.1986/3.7.1986. In case of direct recruitment, recruitment year would be the year of initiating the recruitment process i.e. sending the requisition to the recruiting agency. In case of promotion, the recruitment year would be the year of sending the proposal to UPSC/Chairman-DPC for convening the DPC.

3. The direct recruits are ranked inter-se in the order of merit reckoned on the basis of final ranking obtained in the examination.

4. The said draft Inter-se Seniority may be viewed at the DME0's website. The relevant stakeholders may submit their comments/feedback/suggestions to the undersigned within 30 days of the publishing the draft inter-se Seniority list.
