# 1. Introduction<sup>1</sup>

# 1.1. Background

- 1.1.1. The Development Monitoring and Evaluation Office (DMEO) (the "Authority") was constituted in September 2015 by merging of the erstwhile Programme Evaluation Office (PEO) and the Independent Evaluation Office (IEO). DMEO is an attached Office of NITI Aayog to fulfil the mandates of monitoring and evaluation assigned to NITI Aayog.
- 1.1.2. The Authority is conducting evaluations of all the Centrally Sponsored Schemes (CSS) of Government of India in the following indicative sectors/projects:
  - Agriculture, Animal Husbandry & Fisheries and Food Processing
  - Women and Child Development
  - Education
  - Urban Transformation & Skill Development
  - Rural Development (excl. MGNREGA)
  - Drinking Water and Sanitation
  - Health
  - Water Resources, Environment & Forest
  - Social Inclusion Law and Order & Justice Delivery
- 1.1.3. The above list of sectors/projects for which the RFP is being floated is not provided in any order in terms of its processing, implementation and finalization. Timeline for finalization of RFP for projects/sectors would be different as they are independent RFPs. The Authority reserves the right not to publish any of the RFP's in any of the sectors/projects mentioned above without assigning any reason for the same. The Authority also reserves the right not to go ahead with any of the RFPs for the sectors/projects mentioned above.

1.1.4. (the "Project") in accordance with the Terms of Reference specified at Schedule-1 (the "TOR").

# 1.2. Request for Proposals

- 1.2.1. The Authority invites proposals (the "Proposals") for selection of a Technical Consultant (the "Consultant") who shall conduct an evaluation study of the Scheme, in accordance with the TOR (collectively the "Consultancy").
- 1.2.2. The Authority intends to select the Consultant through an open competitive bidding process in accordance with the procedure set out herein.
- 1.2.3. The Authority is in the process of floating around nine independent RFPs for nine independent projects inviting separate proposals from eligible applicants for each of them. As these projects would be implemented simultaneously, to ensure high quality of evaluation reports and focused attention given to each package, though the Applicant will be allowed to bid for all the nine RFPs, not more than three Projects will be awarded to a single applicant.
- 1.2.4. Once any applicant/bidder has become the successful bidder ranking first in any of the three projects, other bids from the same applicant for the remaining projects, if any, will automatically become non-responsive and will be treated as ineligible.
- 1.2.5. The discretion of the Authority provided under clause 1.2.3 and 1.2.4 shall be final and binding.

# 1.3. Due diligence by Applicants

Applicants are encouraged to inform themselves fully about the assignment and the local conditions before submitting the Proposal by paying a visit to the Authority, sending written queries to the Authority, and attending a Pre-Proposal Conference on the date and time specified in <u>clause 1.10</u> of Invitation for Proposal.

#### 1.4. Availability of RFP Document

The document can be downloaded from the Official Website of the Authority (<u>https://dmeo.gov.in/tenders</u>) and GEM - Government e-Marketplace (<u>https://gem.gov.in/</u>).

# 1.5. Validity of the Proposal

The Proposal shall be valid for a period of 90 days from the Proposal Due Date (the "PDD") as specified in <u>clause 1.8</u> and <u>Clause 2.17</u>.

# 1.6. Brief description of the Selection Process



The Authority has adopted a two-stage selection process (collectively the "Selection Process") for evaluating the Proposals comprising technical and financial bids to be submitted in two separate sealed envelopes.

In the first stage, a technical evaluation will be carried out as specified in <u>Clause 3.1</u> Based on this technical evaluation, a list of short-listed applicants shall be prepared as specified in <u>Clause 3.2</u>. In the second stage, a financial evaluation will be carried out as specified in <u>Clause 3.3</u>. Proposals will finally be ranked according to their combined technical and financial scores as specified in <u>Clause 3.4</u>. The first ranked Applicant shall be selected for negotiation (the "Selected Applicant").

# 1.7. Currency conversion rate and payment

- 1.7.1. For the purposes of technical evaluation of Applicants, the currency conversion rate would be RBI Reference rate at prevailing rate of on day of PDD.
- 1.7.2. All payments to the Consultant shall be made in INR in accordance with the provisions of this RFP. The Consultant may convert INR into any foreign currency as per Applicable Laws and bear the exchange rate risk, if any, shall be borne by the Consultant.

# 2. Instructions to Applicants

# A. General

# 2.1. Scope of Proposal

- 2.1.1. Detailed description of the objectives, scope of services, Deliverables and other requirements relating to this Consultancy are specified in this RFP. In case an applicant firm possesses the requisite experience and capabilities required for undertaking the Consultancy, it may participate in the Selection Process either individually (the "Sole Firm") or as lead member of a consortium of firms (the "Lead Member") in response to this invitation. The term applicant (the "Applicant") means the Sole Firm or the Lead Member or Universities or Academic Institutions, as the case may be. The manner in which the Proposal is required to be submitted, evaluated and accepted is explained in this RFP.
- 2.1.2. Applicants are advised that the selection of consultant shall be on the basis of an evaluation by the Authority through the Selection Process specified in this RFP. Applicants shall be deemed to have understood and agreed that no explanation or justification for any aspect of the Selection Process will be given and that the Authority's decisions are final without any right of appeal whatsoever.
- 2.1.3. The Applicant shall submit its Proposal in the form and manner specified in this Section 2 (Instruction to Applicants) of the RFP. The Technical Proposal shall be submitted in the form at Appendix-I and the Financial Proposal shall be submitted in the form at Appendix-II. # 2.2. Conditions of Minimum Eligibility of Applicants

- 2.2.1. Applicants must read carefully the minimum conditions of eligibility (the "**Conditions of Eligibility**") provided herein. Proposals of only those Applicants who satisfy the Conditions of Eligibility will be considered for evaluation. The Conditions of Eligibility as specified in the RFP may be relaxed for a particular Applicant, if applicable, subject to furnishing of relevant and valid documents or certificates, supporting such relaxations or exemptions under Applicable Laws.
- 2.2.2. To be eligible for evaluation of its Proposal, the Applicant shall fulfill the following
  - (A) General Eligibility of the Applicant: The Applicant must be a legal entity as per Applicable Laws. The 'legal entity' denotes an organization, business structure that is recognized as a distinct entity under law. It can be an incorporated Company or LLP under Indian Laws or Notfor-profit organizations registered as a Society or a Trust under Indian Laws or academic institutions. The Applicant should not have been debarred or blacklisted by the Central Government, any State Government, a Statutory Authority, or a Public-Sector Undertaking, from participating in any consulting assignment.
  - (B) **Technical Capacity:** The Applicant shall have, over the past 8 (Eight) financial years preceding the PDD, undertaken a minimum of 2 (two) Eligible Assignments as specified in <u>Clause 3.1.5.</u>

- 2.2.3. The Applicant shall enclose with its Proposal, certificate(s) from its Statutory Auditors<sup>5</sup>\$ stating its Annual Total Revenue in any of the 3 (three) financial years out of preceding 5 (five) financial years i.e., FY 2019-20, FY 2020-21, FY 2021-22, FY 2022-23 and FY 2023-24). In the event that the Applicant does not have a statutory auditor, it shall provide the requisite certificate(s) from the firm of Chartered Accountants that ordinarily audits the annual accounts of the Applicant.
- 2.2.4. The Applicant should submit a Power of Attorney (POA) as per the format at Form-4 of Appendix-I; provided, however, that such Power of Attorney would not be required if the Application is signed by a partner of the Applicant in case the Applicant is a partnership firm or limited liability partnership.

In the case of government owned academic institutions in lieu of POA, a letter of authorization duly signed by the competent authority such as Head of the Department, Dean, Registrar, Director etc. will be considered.

- 2.2.5. Any entity which has been barred by the Central Government, any State Government, a statutory authority, or a public sector undertaking, as the case may be, from participating in any project, and the bar subsists as on the date of Proposal, would not be eligible to submit a Proposal either by itself or through its Associate.
- 2.2.6. An Applicant or its Associate should have, during the last three years, neither failed to perform on any agreement, as evidenced by imposition of a penalty by an arbitral or judicial authority or a judicial pronouncement or arbitration award against the Applicant or its Associate, nor

been expelled from any project or agreement nor have had any agreement terminated for breach by such Applicant or its Associate.

2.2.7. While submitting a Proposal, the Applicant should attach clearly marked and referenced continuation sheets in the event that the space provided in the specified forms in the Appendices is insufficient. Alternatively, Applicants may format the specified forms making due provision for incorporation of the requested information.

## **2.3.** Conflict of Interest

- 2.3.1. An Applicant shall not have a conflict of interest that may affect the Selection Process or the Consultancy (the "Conflict of Interest"). Any Applicant found to have a Conflict of Interest shall be disqualified. In the event of disqualification, the Authority reserves the right to take action as per the Bid Security or Bid Security Declaration for, inter alia, the time, cost and effort of the Authority including consideration of such Applicant's Proposal, without prejudice to any other right or remedy that may be available to the Authority hereunder or otherwise.
- 2.3.2. The Authority requires that the Consultant provides professional, objective, and impartial advice and at all times hold the Authority's interests' paramount, avoid conflicts with other assignments or its own interests, and act without any consideration for future work. The Consultant shall not accept or engage in any assignment that would be in conflict with its prior or current obligations to other clients, or that may place it in a position of not being able to carry out the assignment in the best interests of the Authority.
- 2.3.3. Some guiding principles for identifying and addressing Conflicts of Interest have been illustrated in the Guidance Note on conflict of interest at Schedule-3.

#### 2.4. Number of Proposals

No Applicant or its Associate shall submit more than one Application for the Consultancy. An Applicant applying individually or as an Associate shall not be entitled to submit another application either individually or as a member of any consortium, as the case may be. If any Applicant or its Associate is found to submit more than one application either individually or as a member of any consortium, their applications shall be rejected.

#### 2.5. Cost of Proposal

The Applicants shall be responsible for all of the costs associated with the preparation of their Proposals and their participation in the Selection Process including subsequent negotiation, visits to the Authority etc. The Authority will not be responsible or in any way liable for such costs, regardless of the conduct or outcome of the Selection Process.

#### 2.6. Verification of information

Applicants are encouraged to submit their respective Proposals after verification of the documents, reference materials, etc. within the purview of this RFP and the Applicable Laws and regulations or any other matter considered relevant by them.



# 2.7. Acknowledgement by Applicant

- 2.7.1. It shall be deemed that by submitting the Proposal, the Applicant has:
  - (a) made a complete and careful examination of the RFP;
  - (b) received all relevant information requested from the Authority;
  - (c) acknowledged and accepted the risk of inadequacy, error or mistake in the information provided in the RFP or furnished by or on behalf of the Authority; or relating to any of the matters referred to in <u>Clause 2.6</u> above;
  - (d) satisfied itself about all matters, things and information, including matters referred to in <u>Clause 2.6</u> herein above, necessary and required for submitting an informed Application and performance of all of its obligations thereunder;
  - (e) acknowledged that it does not have a Conflict of Interest; and
  - (f) agreed to be bound by the undertaking provided by it under and in terms hereof.
- 2.7.2. The Authority shall not be liable for any omission, mistake or error on the part of the Applicant in respect of any of the above or on account of any matter or thing arising out of or concerning or relating to RFP or the Selection Process, including any error or mistake therein or in any information or data given by the Authority.

#### 2.8. Right to reject any or all Proposals

- 2.8.1. Notwithstanding anything contained in this RFP, the Authority reserves the right to accept or reject any Proposal and to annul the Selection Process and reject all Proposals, at any time without any liability or any obligation for such acceptance, rejection or annulment, and without assigning any reasons thereof.
- 2.8.2. Without prejudice to the generality of Clause 2.8.1, the Authority reserves the right to reject any Proposal if:
  - (a) at any time, a material misrepresentation is made or discovered, or
  - (b) the Applicant does not provide, within the time specified by the Authority, the supplemental information sought by the Authority for evaluation of the Proposal.

Misrepresentation/ improper response by the Applicant may lead to the disqualification of the Applicant. If the Applicant is the Lead Member of a consortium, then the entire consortium may be disqualified / rejected. If such disqualification / rejection occurs after the Proposals have been opened and the highest ranking Applicant gets disqualified / rejected, the Authority reserves the right to annul the Selection Process.

2.10.2. The Authority reserves the right not to respond to any questions or provide any clarifications, in its sole discretion, and nothing in this Clause 2.10 shall be construed as obliging the Authority to respond to any question or to provide any clarification.

# 2.11. Amendment of RFP

Applicants will ordinarily not be asked to provide additional material information or documents subsequent to the date of submission, and unsolicited material if submitted will be summarily rejected. For the avoidance of doubt, the Authority reserves the right to seek clarifications under and in accordance with the provisions of <u>Clause 2.24</u>.
- 2.13.6. The Authority is neither a party nor a principal in the relationship between the Applicant and the organisation hosting the e-procurement portal (hereinafter called the Portal). Applicants



must comply with the rules, regulations, procedures, and implied conditions/ agreements of the eProcurement portal, including registration, compatible Digital Signature Certificate (DSC) etc. Consultants shall settle clarifications and disputes, if any, regarding the Portal directly with them.

#### 2.14. Technical Proposal

- 2.14.1. Applicants shall submit the technical proposal online in the formats at Appendix-I (the "Technical Proposal").
- 2.14.2. While submitting the Technical Proposal, the Applicant shall, in particular, ensure that:
  - (a) The Bid Security or Bid Security Declaration is provided;
  - (b) All scanned copies of the forms are submitted in the prescribed formats and signed by the prescribed signatories;
  - (c) Power of Attorney, if applicable, is executed as per Applicable Laws;
  - (d) Duly signed CVs of all Key Personnel and other professional personnel;
  - (e) Key Personnel and other professional personnel have been proposed only if they meet the Conditions of Eligibility laid down at <u>Clause 2.2.2 (E)</u> of the RFP;
  - (f) No alternative proposal for any Key Personnel is being made and only one CV for each position has been furnished;
  - (g) the CVs have been recently signed and dated in blue ink or digitally signed by the respective Personnel, and digitally countersigned by the Applicant. A copy of the CV signed by respective Key Personnel, duly digitally countersigned by the authorised signatory, shall be accepted. If 50%, i.e. 2 out of 4 CVs are not signed by the key personnel, the evaluation should be carried without considering these unsigned CVs and, if this Consultant is still a winner, the signed CVs should be submitted by the Selected Consultant before the award of contract. The replacement of such key personnel are found to be ineligible as per the Clause 2.25.1. If 75%, i.e. 3 out of 40 the CVs are not signed by the respective proposed key personnel, the proposal should be termed as non-responsive and rejected at the technical evaluation stage.
  - (h) The CVs shall contain an undertaking from the respective Key Personnel about his/her availability for the duration specified in the RFP;
  - (i) Professional Personnel proposed have good working knowledge of English language;
  - (j) Key Personnel would be available for the period indicated in the TOR;
  - (k) The proposal is responsive in terms of <u>Clause 2.22.3.</u>



- 2.14.3. Failure to comply with the requirements spelt out in this Clause 2.14 shall make the Proposal liable to be rejected.
- 2.14.4. If an individual Key Personnel makes a false averment regarding his qualification, experience or other particulars, or his commitment regarding availability for the Project is not fulfilled at any stage after signing of the Agreement, he shall be liable to be debarred for any future assignment of the Authority for a period of 5 (five) year. The award of this Consultancy to the Applicant may also be liable to cancellation in such an event.
- 2.14.5. The Technical Proposal shall not include any financial information relating to the Financial Proposal. If done so, the bidder is liable to be rejected.
- 2.14.6. The proposed team shall be composed of experts and specialists (the "Professional Personnel") in their respective areas of expertise and managerial/support staff (the "Support Personnel") such that the Consultant should be able to complete the Consultancy within the specified time schedule. The Key Personnel specified in <u>Clause 2.1.4</u> shall be included in the proposed team of Professional Personnel. Other competent and experienced Professional Personnel in the relevant areas of expertise must be added as required for successful completion of this Consultancy. The CV of each such Professional Personnel, if any, should also be submitted in the format at Form-6 of Appendix-I.
- 2.14.7. The Authority reserves the right to verify all statements, information and documents, submitted by the Applicant in response to the RFP. Any such verification or the lack of such verification by the Authority to undertake such verification shall not relieve the Applicant of its obligations or liabilities hereunder nor will it affect any rights of the Authority thereunder.
- 2.14.8. In case it is found during the evaluation or at any time before signing of the Agreement or after its execution and during the period of subsistence thereof, that one or more of the eligibility conditions have not been met by the Applicant or the Applicant has made material misrepresentation or has given any materially incorrect or false information, the Applicant shall be disqualified forthwith if not yet appointed as the Consultant either by issue of the LOA or entering into of the Agreement, and if the Selected Applicant has already been issued the LOA or has entered into the Agreement, as the case may be, the same shall, notwithstanding anything to the contrary contained therein or in this RFP, be liable to be terminated, by a communication in writing by the Authority without the Authority being liable in any manner whatsoever to the Applicant or Consultant, as the case may be.

In such an event, the Authority reserves the right to take action as per the Bid Security or Bid Security Declaration for, inter alia, time, cost and effort of the Authority, without prejudice to any other right or remedy that may be available to the Authority.

#### 2.15. Financial Proposal

2.15.1. Applicants shall submit online the financial proposal in the formats at Appendix-II (the "Financial Proposal", clearly indicating the total cost of the Consultancy (Item [F] of Form-2 of <u>Appendix-II</u>) in both figures and words, in Indian Rupees (INR or ₹), and signed by the Applicant's Authorised Representative. In the event of any difference between figures and



words, the amount indicated in words shall prevail. In the event of a difference between the arithmetic total and the total shown in the Financial Proposal, the lower of the two shall prevail.

# 2.15.2. While submitting the Financial Proposal, the Applicant shall ensure the following:

- (i) All the costs associated with the assignment shall be included in the Financial Proposal. These shall cover remuneration for all the Personnel (Resident, in the field, office etc.), accommodation, air fare, equipment, printing of documents, surveys, geo-technical investigations etc. The total amount indicated in the Financial Proposal shall be without any condition attached or subject to any assumption, and shall be final and binding. In case any assumption or condition is indicated in the Financial Proposal, it shall be considered non-responsive and liable to be rejected.
- (ii) The Financial Proposal shall take into account all expenses and tax liabilities. For the avoidance of doubt, it is clarified that all taxes shall be deemed to be included in the costs shown under different items of the Financial Proposal. Further, all payments shall be subject to deduction of taxes at source as per Applicable Laws.
- (iii) Costs (including breakdown of costs) shall be expressed in INR.

# 2.16. Submission of Proposal

- 2.16.1. The Applicants shall submit electronically the Proposal with all pages numbered serially and by giving an index of submissions. Each page of the submission shall be digitally signed by the Authorised Representative of the Applicant as per the terms of the RFP. In case the proposal is submitted on the document downloaded from the Official Website, the Applicant shall be responsible for its accuracy and correctness as per the version uploaded by the Authority and shall ensure that there are no changes caused in the content of the downloaded document. In case of any discrepancy between the downloaded or photocopied version of the RFP and the original RFP issued by the Authority, the latter shall prevail.
- 2.16.2. The proposal shall need to be submitted online on the GeM Portal itself; manual/offline bids shall not be accepted under any circumstances. Also, the applicant shall have to separately send Bid Security or Bid Security Declaration and Notorised Power of Attorney in original hard copy to the Authority as specified in the <u>Clause 2.13.4</u>
- 2.16.3. The Technical and Financial bids must be submitted online in their respective folders, one clearly marked "Technical Proposal" and the other clearly marked "Financial Proposal'. The folder marked —Technical Proposal shall contain:
  - (i) Application in the prescribed format (Form-1 of Appendix-I) along with Forms 2 to 13 of Appendix-I and supporting documents; and
  - (ii) Scanned copy of Bid security Declaration or Bid Security Declaration as specified in <u>Clause 2.20.1</u>

The folder marked —Financial Proposal shall contain the Financial Proposal in the prescribed format (Forms 1, 2 & 3 of Appendix-II).



- 2.16.4. All pages of the Technical Proposal and Financial Proposal must be numbered and digitally signed by the Authorised Representative of the Applicant.
- 2.16.5. The complete Proposal must be submitted online on or before 17:00 hours on the Proposal Due Date specified in <u>Clause 1.8</u>. Proposals submitted by post, fax, telex, telegram, in-person or e-mail shall not be entertained.
- 2.16.6. The Proposal shall be made in the Forms specified in this RFP. Any attachment to such Forms must be provided on separate pages and only information that is directly relevant should be uploaded. This may include scanned photocopies of the relevant pages of printed documents. No separate documents like printed annual statements, company brochures, etc. will be entertained.
- 2.16.7. The rates quoted shall be firm throughout the period of performance of the assignment up to and including acceptance of the Consultancy by the Authority and discharge of all obligations of the Consultant under the Agreement.

# 2.17. Proposal Due Date

- 2.17.1. Proposal should be submitted online on the GEM portal, on or before 17:00 hours on the Proposal Due Date specified in <u>Clause 1.8</u> in the manner and form as detailed in this RFP. The Applicant is advised to retain the acknowledgement of the online submission of the bid for future reference.
- 2.17.2. The Authority may, in its sole discretion, extend the Proposal Due Date by issuing an Addendum in accordance with <u>Clause 2.11</u> uniformly for all Applicants.

# 2.18. Late Proposals

Proposals submitted after the due date will not be accepted by the GeM portal and hence will automatically be rejected. DMEO will in no case be responsible if the bid is not submitted online with in the specified timelines.

#### 2.19. Modification/ substitution/ withdrawal of Proposals

- 2.19.1. The Applicant may modify, substitute, or withdraw its proposal by logging into the GEM portal prior to the proposal due date and time.
- 2.19.2. No Proposal shall be modified, substituted, or withdrawn by the Applicant on or after the Proposal Due Date.
- 2.19.3. Any request for alteration / modification in the Proposal or additional information or material supplied subsequent to the Proposal Due Date shall be disregarded.

#### 2.20. Bid Security

2.20.1. The Applicant shall furnish as part of its Proposal, a bid security of ₹ 7 lakhs in the form of Insurance Surety Bonds/Demand Draft/ Account Payee/ Fixed Deposit/ Receipt/ Banker's



Cheque /Bank Guarantee (including e-Bank Guarantee) issued by one of the Nationalized/ Scheduled Banks in India in favour of PAO, NITI Aayog payable at New Delhi, except Micro and Small Enterprises (MSEs) as defined in MSE Procurement Policy issued by Department of Micro, Small and Medium Enterprises (MSME) or are registered with the Central Purchase Organization or the concerned Ministry or Department [or Startups as recognized by Department for Promotion of Industry and Internal Trade (DPIIT).

- 2.20.2. Bid security is returnable not later than 30 (thirty) days from PDD except in case of the two highest ranked Applicants as required in <u>Clause 2.25.1</u>. In the event that the first ranked Applicant commences the assignment as required in <u>Clause 2.30</u>, the second ranked Applicant, who has been kept in reserve, shall be returned its Bid Security forthwith, but in no case later than 120 (one hundred and twenty) days from PDD. After the award of the contract, the Selected Applicant 's Bid Security shall be returned within 30 (thirty) days on receipt of the performance security in accordance with the provisions thereof. Bid securities of the unsuccessful bidders during first stage i.e. technical evaluation, would be returned within 30 days of declaration of results of the technical evaluation. In case of government owned universities/academic institutions, the Applicant shall furnish, as part of its Proposal, a Bid Security Declaration (instead of bid security) as per format specified in <u>Appendix-I Form-11</u>. Universities/academic institutions (hereunder referred to as universities/institutions) should be recognized by University Grant Commission or any State or the Central Government.
- 2.20.3. Any Bid not accompanied by the Bid Security or Bid Security Declaration, as the case may be, shall be rejected by the Authority as non-responsive
- 2.20.4. The authority shall not be liable to pay any interest on the Bid Security and the same shall be interest free.
- 2.20.5. The Applicant, by submitting its Application pursuant to this RFP, shall be deemed to have acknowledged that without prejudice to the Authority's any other right or remedy hereunder or in law or otherwise, the Authority reserves the right to forfeit the bid security or take action as per the Bid Security Declaration for, inter alia, the time, cost and effort of the Authority in regard to the RFP including the consideration and evaluation of the Proposal under the following conditions:
  - a. If an Applicant submits a non-responsive Proposal;
  - b. If an Applicant engages in any of the Prohibited Practices specified in Section 4 of this RFP
  - c. If an Applicant withdraws its Proposal during the period of its validity as specified in this RFP and as extended by the Applicant from time to time;
  - d. In the case of the Selected Applicant, if the Applicant fails to reconfirm its commitments during negotiations as required vide <u>Clause 2.25.1</u>;
  - e. In the case of a Selected Applicant, if the Applicant fails to sign the Agreement or commence the assignment as specified in <u>Clauses 2.29</u> and <u>2.30</u> respectively; or



f. If the Applicant is found to have a Conflict of Interest as specified in Clause 2.3.

## 2.21. Performance Security

- 2.21.1. The Applicant, by submitting its Application pursuant to this RFP, shall be deemed to have acknowledged that without prejudice to the Authority's any other right or remedy hereunder or in law or otherwise, its Performance Security shall be forfeited and appropriated by the Authority
- 2.21.2. An amount equal to 3% (three per cent) of the Agreement Value shall be deemed to be the Performance Security for the purposes of this Clause 2.21, which may be forfeited and appropriated in accordance with the provisions hereof. Performance Security may be furnished in the form of Insurance Surety Bond/Bank Guarantee (including e-Bank Guarantee), Account Payee Demand Draft, Fixed Deposit receipt issued by one of the Nationalized/Scheduled Banks in India.
- 2.21.3. Bid security shall be refunded to the successful bidder on receipt of Performance Security.
- **D. Evaluation Process**

#### 2.22. Evaluation of Proposals

- 2.22.1. The Authority shall open the Proposals at 17:00 hours on the next working day after the Proposal Due Date via online bid opening. The folder of Technical Proposal shall be opened first. The folder of Financial Proposal shall be kept locked for opening at a later date.
- 2.22.2. Proposals withdrawn prior to proposal due date shall not be considered for evaluation in accordance with <u>Clause 2.19.</u>
- 2.22.3. Prior to evaluation of Proposals, the Authority will determine whether each Proposal is responsive to the requirements of the RFP. The Authority may, in its sole discretion, reject any Proposal that is not responsive hereunder. A Proposal may be considered responsive if:

a. The Technical Proposal is received in the form specified at <u>Appendix-I</u>; (All forms to be scanned and uploaded in pdf form on GeM Portal duly signed by the authorized signatory, statutory auditor and/or key personnel, as applicable)

b. it is received by the Proposal Due Date including any extension thereof pursuant to Clause 2.17;

c. It is accompanied by the Bid Security or Bid Security Declaration Form as specified in <u>Clause 2.20.1.</u>

- d. It is digitally signed, numbered and submitted as stipulated in <u>Clauses 2.13</u> and 2.16;
- e. It is accompanied by the Power of Attorney as specified in Clause 2.2.4;
- f. It contains all the information (complete in all respects) as requested in the RFP;



- g. It does not contain any condition or qualification; and
- h. It is not non-responsive in terms hereof.
- 2.22.4. The Authority reserves the right to reject any Proposal which is non-responsive and no request for alteration, modification, substitution, or withdrawal shall be entertained by the Authority in respect of such Proposals.
- 2.22.5. The Authority shall subsequently examine and evaluate Proposals in accordance with the Selection Process specified at <u>Clause 1.6</u> and the criteria set out in Section 3 of this RFP.
- 2.22.6. After the technical evaluation, the Authority shall prepare a list of pre-qualified and shortlisted Applicants in terms of <u>Clause 3.2</u> for opening of their Financial Proposals. A date, time and venue will be notified to all Applicants for announcing the result of evaluation and opening of Financial Proposals. Before opening of the Financial Proposals, the list of pre-qualified and shortlisted Applicants along with their Technical Score will be read out. The opening of Financial Proposals shall be done in presence of respective representatives of Applicants who choose to be present. The Authority will not entertain any query or clarification from Applicants who fail to qualify at any stage of the Selection Process. The financial evaluation and final ranking of the Proposals shall be carried out in terms of <u>Clauses 3.3</u> and <u>3.4</u>.
- 2.22.7. Applicants are advised that selection shall be based on their meeting various criteria enumerated in the different clauses of the RFP. Applicants shall be deemed to have understood and agreed that the Authority shall not be required to provide any explanation or justification in respect of any aspect of the selection process or selection.
- 2.22.8. Any information contained in the Proposal shall not in any way be construed as binding on the Authority, its agents, successors or assigns, but shall be binding against the Applicant if the Consultancy is subsequently awarded to it.
- 2.22.9. Deviations/Omissions: During the evaluation of proposals, the following definitions apply:

a. "Deviation" is a departure from the requirements specified in the RFP document;

b."Omission" is failing to submit part or all of the information or documentation required in the RFP Document;

The decision of the Authority shall be final in this regard.

#### 2.23. Confidentiality

Information relating to the examination, clarification, evaluation, and recommendation for the selection of Applicants shall not be disclosed to any person who is not officially concerned with the process or is not a retained professional adviser advising the Authority in relation to matters arising out of, or concerning the Selection Process. The Authority shall treat all information, submitted as part of the Proposal, in confidence and shall require all those who have access to such material to treat the same in confidence. The Authority may not divulge any such information unless it is directed to do so by any statutory entity that has the power



under law to require its disclosure or is to enforce or assert any right or privilege of the statutory entity and/or the Authority or as may be required by law or in connection with any legal process.

### 2.24. Clarification

- 2.24.1. To facilitate evaluation of Proposals, the Authority may, at its sole discretion, seek clarifications from any Applicant regarding its Proposal. Such clarification(s) shall be provided within the time specified by the Authority for this purpose. Any request for clarification(s) and all clarification(s) in response thereto shall be in writing.
- 2.24.2. If an Applicant does not provide clarifications sought under Clause 2.24.1 above within the specified time, its Proposal shall be liable to be rejected. In case the Proposal is not rejected, the Authority may proceed to evaluate the Proposal by construing the particulars requiring clarification to the best of its understanding, and the Applicant shall be barred from subsequently questioning such interpretation of the Authority.

## E. Appointment of Consultant

### 2.25. Negotiations

- 2.25.1. The Selected Applicant may, if necessary, be invited for negotiations. The negotiations shall generally be for re-confirming the obligations of the Consultant under this RFP. Issues such as deployment of Key Personnel, understanding of the RFP, methodology and quality of the work plan shall be discussed during negotiations. There shall be no change in the scope of the work/services during negotiation. Up to two Key Personnel who is/are not eligible as required under <u>Clause 2.2.2 (E)</u> shall be replaced by the Applicant with better candidate (s) to the satisfaction of the Authority. In case the Selected Applicant fails to reconfirm its commitment, the Authority reserves the right to forfeit the bid security or Bid security declaration of the Applicant in accordance with the provisions of <u>Clause 2.2.05</u>.
- 2.25.2. The Authority will examine the CVs of all other Professional Personnel and those not found suitable shall be replaced by the Applicant to the satisfaction of the Authority.
- 2.25.3. Before issuing a Letter of Award (LoA) to the successful Applicant, the Authority may, at its discretion, ask the selected Applicant to submit self-attested copies of relevant certificates for minimum educational qualifications and proof of relevant experiences, given in the CVs in the proposal, of the Key Personnel for verification. If so decided, the photocopies of such self-certified documents shall be verified and signed by the competent officer and kept in the records as part of the contract agreement. If the consultant fails to provide such originals or in case of substantive discrepancies in such documents, the proposal will be considered as non-responsive and rejected thereon. In such cases, the Authority may forfeit the Bid Security or/and initiate suitable action as per the provision of Bid Security Declaration.
- 2.25.4. As a pre-requisite to the negotiations, the Selected Applicant shall confirm the availability of all Key Personnel included in the Proposal. Failure to confirm the Key Personnel availability may result in the Applicant's Proposal being declared non-responsive and the Authority



proceeding to negotiate the Contract with the next-ranked responsive applicant. Notwithstanding the above, the substitution of Key Personnel at the negotiations may be considered if due solely to circumstances outside the reasonable control of and not foreseeable by the applicant, including but not limited to death or medical incapacity. In such a case, the Selected Applicant shall offer a substitute Key Personnel within the period specified in the invitation letter to negotiate the Contract, who shall have equivalent or better qualifications and experience than the original candidate. Authority reserves its right to seek during negotiations the replacement of the Key Personnel, subject to the maximum limit of two, who are found to be ineligible

2.25.5. The negotiations are concluded with a review of the finalized draft Contract, which shall be initiated by the Authority and the Applicant's authorized representative. If the negotiations fail, the Authority shall inform the Applicant in writing of all pending issues and disagreements and provide a final opportunity for the Applicant to respond. If disagreement persists, the Authority shall declare the proposal non-responsive, informing the Applicant to negotiate a Contract. Once the Authority shall invite the next-ranked responsive Applicant to negotiate a Contract. Once the Authority commences negotiations with the next-ranked Applicant, the Authority shall not reopen the earlier negotiations. In case, the second ranked applicant is invited for negotiation, the lower cost, as per financial proposals, between the highest ranked applicant and the second highest ranked applicant shall be offered to the second highest ranked applicant for the award of contract.

#### 2.26. Substitution of Key Personnel

- 2.26.1. The Authority will not normally consider any request of the Selected Applicant for substitution of Key Personnel as the ranking of the Applicant is based on the evaluation of Key Personnel and any change therein may upset the ranking. Substitution will, however, be permitted if the Key Personnel is not available for reasons of medical incapacity or death, subject to equally or better qualified and experienced personnel being provided to the satisfaction of the Authority.
- 2.26.2. The Authority expects all the Key Personnel to be available during implementation of the Agreement. The Authority will not consider substitution of Key Personnel except for reasons of medical incapacity or death. Such substitution shall ordinarily be limited to one Key Personnel subject to equally or better qualified and experienced personnel being provided to the satisfaction of the Authority. As a condition to such substitution, a sum equal to 10% (ten per cent) of the remuneration specified for the original Key Personnel shall be deducted from the payments due to the Consultant. In the case of a second substitution hereunder, such deduction shall be 20% (twenty per cent) of the remuneration specified for the original Key Personnel. Any further substitution may lead to disqualification of the Applicant or termination of the Agreement.
- 2.26.3. Substitution of the Team Leader will not normally be considered and may lead to disqualification of the Applicant or termination of the Agreement.



2.26.4. In case the Authority is not satisfied with the performance of any Key Personnel, the Authority may initiate a request for substitution of such Key Personnel. This substitution will also be subject to payment deductions as described in Clause 2.26.2.

### 2.27. Indemnity

The Consultant shall, subject to the provisions of the Agreement, indemnify the Authority for an amount not exceeding 3 (three) times the value of the Agreement for any direct loss or damage that is caused due to any deficiency in services.

## 2.28. Award of Consultancy

After selection, a Letter of Award (the "LOA") shall be issued, in duplicate, by the Authority to the Selected Applicant and the Selected Applicant shall, within 7 (seven) days of the receipt of the LOA, sign and return the duplicate copy of the LOA in acknowledgement thereof. In the event the duplicate copy of the LOA duly signed by the Selected Applicant is not received by the stipulated date, the Authority may, unless it consents to extension of time for submission thereof, reserves the right to take action as per the Bid Security or Bid Security Declaration of such Applicant as mutually agreed genuine pre-estimated loss and damage suffered by the Authority on account of failure of the Selected Applicant to acknowledge the LOA.

### 2.29. Execution of Agreement

After acknowledgement of the LOA as aforesaid by the Selected Applicant, it shall execute Agreement within the period prescribed in <u>Clause 1.8</u>. The Selected Applicant shall not be entitled to seek any deviation in the Agreement.

## 2.30. Commencement of assignment

The Consultant shall commence the Services within 7 (seven) days of the date of the Agreement, or such other date as may be mutually agreed. If the Consultant fails to either sign the Agreement as specified in Clause 2.29 or commence the assignment as specified herein, the Bid Security of the Consultant shall be forfeited or action shall be undertaken by the Authority as per the Bid Security Declaration in accordance with the provisions of <u>Clause 2.20.4</u>.

## 2.31. Proprietary Data

Subject to the provisions of <u>Clause 2.23</u>, all documents and other information provided by the Authority or submitted by an Applicant to the Authority shall remain or become the property of the Authority. Applicants and the Consultant, as the case may be, are to treat all information as strictly confidential. The Authority will not return any Proposal or any information related thereto. All information collected, analyzed, processed or in whatever manner provided by the Consultant to the Authority in relation to the Consultancy shall be the property of the Authority. The Consultant shall make suitable arrangements for the preservation of data collected during the study, such as filled in schedules, tabulation or working sheets, reports, photographs etc., relating to the Project in electronic form and this shall be shared with the Authority at the time



of submission of Final report. The ownership of all such data shall remain with the Authority. All raw data compiled during the consultancy assignment shall be transferred to the authority. No data collected in context of the study may be destroyed or otherwise disposed of or given to any other organization/individual, unless so approved by the Authority.

## 3. Criteria for Evaluation

# 3.1. Evaluation of Technical Proposals

- **3.1.1.** In the first stage, the Technical Proposal will be evaluated based on Applicant's experience, its understanding of TOR, proposed methodology and Work Plan, and the experience and qualifications of the proposed Key Personnel. Only those Applicants whose Technical Proposals get a score of 70 (seventy) marks or more out of 100 (one hundred) shall qualify for further consideration and shall be ranked from highest to the lowest based on their technical score.
- **3.1.2.** A Proposal shall be rejected if three or more Key Personnel are not eligible. In case the Selected Applicant has one or two Key Personnel who is/are not eligible, she/ they would have to be replaced during negotiations, with better candidate (s) who, in the opinion of the Authority, would be eligible as per the <u>Clause 2.2.2 (E)</u>. However, if the team leader is found not eligible then the proposal will be rejected.
- **3.1.3.** And, technical score  $(S_T)$  is calculated by considering the highest Technical Proposal  $(T_{Max})$  will be given a technical score  $(S_T)$  of 100 points. The technical scores of other proposals will be computed as follows:

$$S_T = 100 \text{ x T} / T_{Max}$$

(T = absolute score of Technical Proposal)

## 3.1.5. Eligible Assignments

For the purposes of determining Conditions of Eligibility and for evaluating the Proposals under this RFP, advisory/ consultancy assignments, for the following projects shall be deemed as eligible assignments (the "Eligible Assignments"):

- Assessment/research/evaluation study in **Urban Transformation** conducted for Union/State Government, regulatory commission, tribunal, bilateral agencies, multilateral agencies, statutory authorities, public sector entities in India covering a minimum sample size of **500 respondents.**
- Provided that the Eligible Assignments have been completed in the 8 (eight) financial years preceding the PDD,
- Provided that the Applicant firm claiming credit for an Eligible Assignment shall have a value of at **least Rs 25 lakhs** for such assignment.
- For the Eligible Assignments, the Applicant shall provide requisite supporting documents such as copies of contracts, agreements etc. The value for the assignment should be clearly mentioned in the supporting documents provided. In the absence of supporting documents with requisite details, the assignment will not be considered as an Eligible Assignment.

# 3.2. Shortlisting of Applicants

The technical qualified applicants shall be short-listed for financial evaluation in the second stage.

## 3.3. Evaluation of Financial Proposals



- 3.3.1. In the second stage, the financial evaluation will be carried out as per Clause 3.3. The financial score  $(S_F)$  for the applicant will be arrived at based on the formula given in clause 3.3.3.
- 3.3.2. For financial evaluation, the total cost indicated in the Financial Proposal will be considered
- 3.3.3. The Authority will determine whether the Financial Proposals are complete, unqualified and unconditional. The cost indicated in the Financial Proposal shall be deemed as final and reflecting the total cost of services. Omissions, if any, in costing any item shall not entitle the firm to be compensated and the liability to fulfill its obligations as per the TOR within the total quoted price shall be that of the Consultant The lowest Financial Proposal (F<sub>Min</sub>) will be given a financial score (S<sub>F</sub>) of 100 points. The financial scores of other proposals will be computed as follows:

$$S_F = 100 \times F_{Min}/F$$

(F = amount of Financial Proposal)

# 3.4. Combined and Final Evaluation

3.4.1. Proposals will finally be ranked according to their combined technical  $(S_T)$  and financial  $(S_F)$  scores as follows:

$$S = S_T \times T_w + S_F \times F_w$$

Where, S is the combined score, and  $T_w$  and  $F_w$  are weights assigned to Technical Proposal and Financial Proposal, which shall be 0.70 and 0.30 respectively.

3.4.2. The Selected Applicant shall be the first ranked Applicant (having the highest combined score). The Authority reserves the right to take action as per the Bid Security Declaration in accordance with the provisions of <u>Clause 2.20.5</u>, in case the first-ranked Applicant withdraws, or fails to comply with the requirements specified in <u>Clauses 2.25</u>, <u>2.29</u> and <u>2.30</u>, as the case may be.



## 4. Fraud and Corrupt Practices

- 4.1. The Applicants and their respective officers, employees, agents and advisers shall observe the highest standard of ethics during the Selection Process. Notwithstanding anything to the contrary contained in this RFP, the Authority shall reject a Proposal without being liable in any manner whatsoever to the Applicant, if it determines that the Applicant has, directly or indirectly or through an agent, engaged in corrupt practice, fraudulent practice, anti-competitive practice, coercive practice, conflict of interest, obstructive practice in the Selection Process. In such an event, the Authority shall, without prejudice to its any other rights or remedies, take action as per the Bid Security or Bid Security Declaration, or forfeit and appropriate the Performance Security, as the case may be, as mutually agreed genuine pre-estimated compensation and damages payable to the Authority for, *inter alia*, time, cost and effort of the Authority, in regard to the RFP, including consideration and evaluation of such Applicant's Proposal.
- 4.2. Without prejudice to the rights of the Authority under Clause 4.1 hereinabove and the rights and remedies which the Authority may have under the LOA or the Agreement, if an Applicant or Consultant, as the case may be, is found by the Authority to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, anti-competitive practice, conflict of interest, obstructive practice or anti-competitive practice, conflict of interest, obstructive practice, during the Selection Process, or after the issue of the LOA or the execution of the Agreement, such Applicant or Consultant shall not be eligible to participate in any tender or RFP issued by the Authority during a period of 2 (two) years from the date such Applicant or Consultant, as the case may be, is found by the Authority to have directly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, fraudulent practice, anti-competitive practice, conflict of interest, obstructive practice or coercive practice or consultant, as the case may be, is found by the Authority to have directly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, anti-competitive practice, conflict of interest, obstructive practice or anti-competitive practice, fraudulent practice, anti-competitive practice, conflict of interest, obstructive practice or anti-competitive practice, conflict of interest, obstructive practice, as the case may be.
- 4.3. For the purposes of this Section, the following terms shall have the meaning hereinafter respectively assigned to them:
  - (a) "Corrupt practice" means making an offer, solicitation or acceptance of a bribe, reward ,gift or any material benefit in exchange for an unfair advantage in the Procurement Process or to otherwise influence the Procurement Process
  - (b) "Fraudulent practice" means any omission or misrepresentation that may mislead or attempt to mislead so that financial or other benefits may be obtained or an obligation avoided. Such practices include a false declaration or false information for participation in a Procurement Process or to secure a Contract, or in the execution of the agreement
  - (c) "Coercive practice" means harming or threatening to harm persons or their property to influence their participation in the Procurement Process or affect the execution of the agreement
  - (d) "Anti-competitive practice" means any collusion, Proposal-rigging or anti-competitive arrangement, or any other practice including cartels coming under the purview of the Competition Act, 2002, between two or more Applicants, with or without the knowledge of the Authority, that may impair the transparency, fairness, and the progress of the



Procurement Process or to establish Proposal prices at artificial, non-competitive levels

- (e) Conflict of interest" means participation by a bidding firm or any of its affiliates who are either involved in the Consultancy Contract to which this procurement is linked; if they are part of more than one Proposal in the procurement; or if their personnel have a relationship or financial or business transactions with any official of Authority who are directly or indirectly related to tender or execution process of contract; or improper use of information obtained by the (prospective) Applicant from the Authority with an intent to gain unfair advantage in the Procurement Process or for personal gain
- (f) "Obstructive practice" means materially impeding Authority's investigation into allegations of one or more of the above-mentioned prohibited practices either by deliberately destroying, falsifying, altering; or by concealing evidence material to the investigation; or by making false statements to investigators and/ or by threatening, harassing or intimidating any party threatening, harassing or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation, or by impeding the Authority's rights of an audit or access to information



## 5. Miscellaneous

- 5.1. The Selection Process shall be governed by, and construed in accordance with, the laws of India and the Courts in the State in which the Authority has its headquarters shall have exclusive jurisdiction over all disputes arising under, pursuant to and/or in connection with the Selection Process.
- 5.2. The Authority, in its sole discretion and without incurring any obligation or liability, reserves the right, at any time, to:
  - (a) suspend and/or cancel the Selection Process and/or amend and/or supplement the Selection Process or modify the dates or other terms and conditions relating thereto;
  - (b) consult with any Applicant in order to receive clarification or further information;
  - (c) retain any information and/or evidence submitted to the Authority by, on behalf of and/or in relation to any Applicant; and/or
  - (d) independently verify, disqualify, reject and/or accept any and all submissions or other information and/or evidence submitted by or on behalf of any Applicant.
- 5.3. It shall be deemed that by submitting the Proposal, the Applicant agrees and releases the Authority, its employees, agents and advisers, irrevocably, unconditionally, fully and finally from any and all liability for claims, losses, damages, costs, expenses or liabilities in any way related to or arising from the exercise of any rights and/or performance of any obligations hereunder, pursuant hereto and/or in connection herewith and waives any and all rights and/or claims it may have in this respect, whether actual or contingent, whether present or future.
- 5.4. All documents and other information supplied by the Authority or submitted by an Applicant shall remain or become, as the case may be, the property of the Authority. The Authority will not return any submissions made hereunder. Applicants are required to treat all such documents and information as strictly confidential.
- 5.5. The Authority reserves the right to make inquiries with any of the clients listed by the Applicants in their previous experience record.

# Quality Assurance of the Evaluation Report

The evaluation report submitted by the Consultant must comply with DMEO's quality standards in order to be accepted. In case of any compromise in the quality of the deliverables, a suitable penalty would be imposed on the Consultant as per the provisions given in the RFP.

An indicative quality standard followed by DMEO is given below. The consultant may include more such standards to further enhance the report quality.

# a. Executive Summary (ES)

The executive summary (ES) is meant to be read by a wider audience, thus it must be written with extreme neatness and attention to detail. It should be written with clarity, coherence, and crispness. Findings of the report should be elaborated with key statistics and recommendations following from findings. The ES should offer more than just a synopsis of the chapters; it should also triangulate all the evidence obtained during the study from the primary survey and secondary data and policy implications to flow from such findings. The ES should be forthright in its observations, precise in its deductions, and proactive in its suggestions. ES should ideally be written in short, separate paragraphs that do not exceed five pages. All data/findings/recommendations cited from the main report need to be properly referenced using page numbers. The ES should only briefly touch upon the evaluation questions, issues, and problems. The ES needs to be sharp and centered on the conclusions and suggestions emerging from the evaluation study.

## b. Professional Language and Referencing

The report should be written in a professional manner and in accordance with the standards of a typical double-blind, peer-reviewed publication. The report should be free from grammatical errors, plagiarism, and spelling mistakes. Reports with more than 20 percent plagiarised content will not be accepted. Plagiarism will be ascertained through software/tools such as Turnitin etc. It must adhere to the suggested report structure, and appropriately referenced with necessary citations. Any data, diagrams, and graphs must be appropriately labeled and referenced.

## c. Objective Findings and Recommendation

The report should be a succinct, stand-alone document with objective language that may be used to inform decision-making. The findings should be presented clearly, providing sufficient evidence,



and systematically addressing all the evaluation objectives. The recommendations should be clearly formulated and logically derived from the findings of the report. It should be clearly articulated and prioritized based on their importance and potential impact for the improvement of the scheme. The conclusions drawn from primary and secondary research must be given equal weight. Recommendations that lead to an increased financial burden on the government (such as those on increasing budgetary allocation) should be avoided, unless there is sound evidence emerging from the analysis that an increase may be expedient. Focus should be on resource optimisation/judicious usage of resources.

d. Ethical Considerations and Data Protection

Ethical considerations, such as confidentiality and data protection, and data quality, must be upheld throughout the process.



# Section A: Urban Transformation

## 1. Background of the Sector

Urbanization in India has become an important and irreversible process, and it is an important determinant of national economic growth and poverty reduction. The process of urbanization is characterized by a dramatic increase in the number of small and medium towns, although India may be said to be in the midst of the transition from a predominantly rural to a quasi-urban society.

While rapid urbanization brings in new growth opportunities, it also poses several challenges. A comprehensive development of physical, institutional, social, and economic infrastructure is required to sustain this urban growth.

The transition has to be accompanied by a commensurate increase in the supply of basic urban services like water supply, sewerage, drainage network, solid/liquid waste management facilities, citywide roads, public transport, and public safety systems like street lighting and pedestrian pathways.

More than 31 percent of the total population is urban population in India. At the current rate of growth, the urban population in India is estimated to reach a staggering 575 million by 2030 A.D.

Infrastructural challenges in terms of affordable housing, access to clean drinking water, electricity, roads, etc. are the key priorities of the Government.

Intending to develop the urban areas that make cities more liveable, efficient, and productive, the Government of India has adopted a multi-pronged strategy. Developing 100 cities under the Smart Cities Mission (SCM), rejuvenating 500 AMRUT cities, providing affordable housing to all, making cities cleaner and open defecation free, and developing livelihood opportunities under DAY-NULM, are part of an approach to make cities sustainable and more liveable. Following is the current achievement status :

- a. 78.15 lakh houses have been constructed/delivered as of November 2023 since 2015 under Pradhan Mantri Awas Yojana- Urban<sup>10</sup>.
- b. Under Smart Cities Mission, as of November 2023, work orders have been issued in 7,959 projects worth around ₹ 1,71,224 crore; out of this 6,271 projects worth ₹1,16,269 crore have been completed11.
- c. AMRUT has provided 1.87 crore new/serviced tap connections, helping connect 70% of urban households to piped water supply. In the sewerage sector, AMRUT has resulted in 2.94 crore sewerage connections/septage facilities in 500 cities<sup>12</sup>.
- d. Under SBM-U, Urban India has become Open Defecation Free (ODF), with all 4,715 Urban Local Bodies (ULBs) completely ODF. 3,547 ULBs are ODF+ with functional and hygienic community and public toilets, and 1,191 ULBs are ODF++ with complete faecal sludge

management.14 cities are certified Water+, which entails treatment of wastewater and its optimum reuse.

The purpose of this document is to facilitate the evaluation of the initiatives taken by the Government of India in the last decade to improve the liveable conditions of Indian Cities and gauge how much India has achieved with regard to the Sustainable Development Goals (GOAL 6: Clean Water and Sanitation, GOAL 8: Decent Work and Economic Growth, GOAL 11: Sustainable Cities and Communities,).

## 1.1 Brief of CSS schemes to be evaluated for the MoHUA

1.1.1. Pradhan Mantri Awas Yojana -Urban , (₹ 26,170 Cr , BE 2024-25)

Pradhan Mantri Awas Yojana (Urban) was launched in June, 2015 to provide Central assistance to implementing agencies through States/Union Territories (UTs) for providing houses to all eligible families/beneficiaries by 2022. Thus, PMAY (U) is being implemented during the period 2015-2024. The scheme focuses to cover the entire urban areas consisting of all statutory towns and areas including Notified Planning/Development Area/Industrial Development Authority/Special Area Development Authority/Urban Development Authority or any such Authority under the State legislation which is entrusted with the functions of urban planning and regulations.

The PMAY (U) has the following four components:

- a) "In-situ" Slum Redevelopment (ISSR) Slum development grant of Rs.1 lakhs per house is admissible for all houses build for eligible slum dwellers under this component using land as resource with participation of private developers.
- b) Credit-Linked Subsidy Scheme (CLSS) Beneficiaries of Economically Weaker Section (EWS)/Low Income Group (LIG), Middle Income Group (MIG)-I and Middle Income Group (MIG)-II seeking housing loans from Banks, Housing Finance Companies and other such institutions for acquiring, new construction or enhancement\* of houses are eligible for an interest subsidy of 6.5%, 4% and 3% on loan amount upto Rs. 6 Lakh, Rs. 9 Lakh and Rs. 12 Lakh respectively.
- c) Affordable Housing in Partnership with public or private sector (AHP)- Central assistance of Rs.1.5. lakhs per EWS house is provided by Govt. of India in projects where at least 35% of the houses in the projects are for EWS category.
- d) Beneficiary- led individual house construction/enhancement (BLC)- Under this component, Central assistance of Rs.1.5 lakh per EWS house is provided to individual eligible families belonging to EWS category.<sup>13</sup>

In light of COVID-19 and ensuin reverse migration, Affordable Rental Housing Complexes (ARHCs) for Migrant Workers/ Urban Poor was introduced as a sub-scheme under PMAY-U. The ARHC is implemented through two models:

i. Utilizing existing Government funded vacant houses to convert into ARHCs through

Public Private Partnership or by Public Agencies

ii. Construction, Operation and Maintenance of ARHCs by Public/ Private Entities on their own vacant land<sup>14</sup>

PMAY (U) was originally to be implemented as a 7 years Mission to provide 'Houses for All' between 2015 to 2022. This Programme has completed about 9 years of its implementation with an extension up till 31.12.2024<sup>15</sup>. The major purpose of this Review is to assess whether the objectives and targets which were set to provide Houses to the EWS/LIG and MIG I & II have been met. Also, whether the Programme is moving ahead in the States/UTs as per the spirit of the Programme Guidelines (refer to Part A Annexure- I for details).

# 1.1.2. Swachh Bharat Mission -Urban, (₹ 5,000 Cr, BE 2024-25)

Swachh Bharat Mission (Urban) was launched by the Hon'ble Prime Minister on 2 October 2014 with the goal of achieving following mission objectives:

- 1. Elimination of open defecation and Eradication of Manual Scavenging
- 2. Modern and Scientific Municipal Solid Waste Management
- 3. To effect behavioral change regarding healthy sanitation practices
- 4. Generate awareness about sanitation and its linkage with public health
- 5. Capacity Augmentation for ULBs to create an enabling environment for private sector participation in Capex (capital expenditure) and Opex (operation and maintenance)

The second phase of SBM-U was launched on 1st October 2021, for a period of 5 years. The vision for SBM-U 2.0 is to achieve "Garbage Free" status for all cities by 2026. The second phase of SBM-U aimed to go beyond ODF to ODF+, and ODF++, and focus on making urban India garbage-free. It emphasized sustainable sanitation practices, waste management, and the promotion of a circular economy

The key objectives of the study will be to assess and quantify the economic and social impacts of the Swachh Bharat Mission (Urban), and Swatch Bharat Mission 2.0. Make recommendations on how to integrate the lessons learned into future projects to sustain the outcomes of the Swachh Bharat Mission (Urban). (refer to Part A Annexure- I for details).

1.1.3. Atal Mission for Rejuvenation and Urban Transformation, AMRUT, (₹ 8,000 Cr, BE 2024-25)

The Goal 6 of Sustainable Development Goals (SDGs) states that there are grave economic, environmental, and public health implications of inadequate water supply, and unscientific wastewater management, particularly in urban areas where population density is high. Providing basic services like

water supply, sewerage, green spaces and parks to households, especially the poor and the disadvantaged is a national priority. Recognizing this, Government of India launched the Atal Mission for Rejuvenation and Urban Transformation (AMRUT) as a Mission mode a Centrally Sponsored Scheme in 25th June 2015 as part of Urban Rejuvenation Mission with the objective of providing urban infrastructure. Under AMRUT the States have assessed the service level gaps and prepared service level improvement plans (SLIP) for cities and aggregated the SLIPs into State Annual Action Plan (SAAP) with an objective to bridge the gap and achieve universal coverage. 500 cities are covered under AMRUT mission,

The purpose of AMRUT mission is

- (i) Ensure that every household has access to a tap with assured water supply (The first priority is to achieve universal coverage of piped drinking water to all households
- (ii) Sewerage facilities(treatment capacities) and septage management / connection to all household
- (iii) Provide storm water drains to reduce flooding; and
- (iv) Reduce pollution by switching to public transport or constructing facilities for nonmotorized transport like walking and cycling.
- (v) Increase the amenities value of the city by developing greenery and well-maintained open spaces;

AMRUT 2.0 is designed to provide universal coverage of water supply through functional taps to all households in all the statutory towns in the country and coverage of sewerage/septage management in 500 cities covered in the first phase of the AMRUT scheme.

AMRUT 2.0 is a step towards AatmaNirbhar Bharat with aim of making the cities 'water secure' and providing functional water tap connections to all households. Mission will co-opt women and youth for concurrent feedbacks about its progress. This will be done as a step to ensure community participation.

The key objectives of the study will be to assess and quantify the economic and social impacts of AMRUT. (refer to Part A Annexure- I for details).

# 1.1.4. Smart Cities Mission (SCM), (₹ 2,400 Cr, BE 2024-25)

Recognizing the importance in improving the quality of life and attracting people and investments to the city and setting in motion a virtuous cycle of growth and development, Government of India has launched the Smart Cities Mission a Centrally Sponsored Scheme during June 2015 as part of Urban Rejuvenation Mission with the objective of providing urban infrastructure and give a decent quality of life to its citizens, a clean and sustainable environment and application of 'Smart' Solutions. The focus is on sustainable and inclusive development and the idea is to look at compact areas, create a replicable model which will act like a light house to other aspiring cities. The Smart Cities Mission of the Government is a bold, new initiative. It is meant to set examples that can be replicated both within and outside the Smart City, catalyzing the creation of similar Smart Cities in various regions and parts of the country.

The core infrastructure elements in a Smart City include

(i) Adequate water supply



- (ii) Assured electricity supply
- (iii) Sanitation, including solid waste management
- (iv) Efficient urban mobility and public transport
- (v) Affordable housing, especially for the poor
- (vi) Robust IT connectivity and digitalization
- (vii) Good governance, especially e-Governance and citizen participation
- (viii) Sustainable Environment
- (ix) Safety and security of citizens, particularly women, children and the elderly
- (x) Health and Education.

The key objectives of the study will be to assess and quantify the economic and social impacts of SCM. (refer to Part A Annexure- I for details)

## 1.1.5. Deendayal Antrodaya Yojana National Urban Livelihoods Mission (DAY- NULM)

National Urban Livelihoods Mission (NULM) was launched by the erstwhile Ministry of Housing and Urban Poverty Alleviation (MHUPA), Government of India in 23rd September, 2013 by replacing the existing Swarna Jayanti Shahari Rozgar Yojana (SJSRY). The NULM will focus on organizing urban poor in their strong grassroots level institutions, creating opportunities for skill development leading to market-based employment and helping them to set up self-employment venture by ensuring easy access to credit. The Mission is aimed at providing shelter equipped with essential services to the urban homeless in a phased manner. In addition, the Mission would also address livelihood concerns of the urban street vendors. The NULM has since been extended to all urban local bodies (ULB)in the country, and has been renamed as Deendayal Antyodaya Yojana – National Urban Livelihoods Mission (DAY-NULM) in 2016.

## Scheme Components

- 1. Social Mobilisation And Institution Development (SM&ID)
- 2. Capacity Building And Training (CB&T)
- 3. Employment through Skills Training & Placement (EST&P)
- 4. Self-Employment Programme (SEP)
- 5. Scheme of Shelters for Urban Homeless (SUH)
- 6. Support to Urban Street Vendors (SUSV)
- 7. Innovative and Special Projects (I&SP)

DAY- NULM Scheme aims to create sustainable livelihood opportunities for the urban poor through a multipronged approach and is being implemented by the Govts. of various states and Union Territories, Urban Local Bodies covering all statutory towns and cities and seeks to achieve the following:

a) To organize urban poor in strong grassroots level institutions.



- b) To create opportunities for skill development "market" based employment.
- c) To assist the urban poor to set up self-employment ventures through easy access to credit.
- d) To provide shelters equipped with essential services to the urban homeless in a phased manner
- e) To address livelihood concerns of the urban street vendors.

DAY-NULM has made significant strides in reaching out to the urban poor and supporting their livelihoods. Till date, 96.7 lakh urban poor households have been brought under SHG fold, over 15.3 Lakh youth are skill trained, 17 Lakh microenterprises are facilitated for setting up their own enterprises, 1,984 permanent Shelters are built for 1.41 Lakh urban homeless and 69 lakh street vendors are supported

The major purpose is to assess the current progress of all the cities on various components of DAY-NULM and quantify the economic and social impacts. (refer to Part A Annexure- I for details).

## 2. <u>Objectives of the Evaluation Study</u>

### 2.1. Sectoral Analysis

- (a) Assess urban sector's performance on the following ease of living parameters (including but not limited to): Infrastructure Services (Housing and inclusiveness, Toilets, Public open spaces, Mixed land use and compactness, Transportation and mobility, and Assured water supply, shelter homes, vending markets, and City Livelihood Centers (CLC) etc.), Governance (Capacity building, citizen participation, IT & e-Governance and financial sustainability, etc.), Natural Resource Management (Waste-water management including recycling and reuse, Solid waste management, etc.) and if applicable, Social Services (Education, Health & Sanitation, Safety & Security). Each of the above parameters should be assessed based on the six principles of access, adequacy, quality, equity, livelihood and sustainability.
- (b) Assess the measure to ensure that high-quality, safe, and sufficient drinking water is available across India irrespective of seasonal variations. Assess how preventive approaches (such as risk-based approach) help to reduce pollution (eg. industrial effluents, non-biodegradable pollutants) at source ensuring better access to safe water. Also identify if measures can be taken up reduce water leakages and increase transparency (wrt administration, implementation, pricing) across all seasons and in all states in India.
- (c) Assess whether the facilities provided under MoHUA's bouquet of schemes is in consonance with urban needs and aspirations.
- (d) Assess the gaps in the broad sectoral outcomes where national priorities/SDGs/ease of living parameters are not being addressed either due to the absence of interventions or nonperformance of existing schemes and policy interventions.
- (e) Other important issues may be addressed in evaluation in consultation with central/state ministries and DMEO, other stakeholders.
- (f) How emerging technologies can provide solution to the current problems.
- 2.2. Scheme level analysis



- a) To assess the implication of transferring funds directly to States with complete freedom to implement schemes rather than CSS to achieve the same outcome objectives as spelt out in respective CSS schemes.
- b) Is there an alternative way to achieve the same objectives more effectively and efficiently?
- c) To assess each CSS scheme on the Relevance, Effectiveness, Efficiency, Sustainability, Impact ,Coherence and Equity framework.
- d) To assess coverage of each of the schemes in terms of eligible target beneficiaries, services, geographies etc. and analyse the reasons for non-coverage, if applicable.
- e) To assess each CSS scheme on various cross-sectional themes, as well as unintended consequences/externalities (positive and negative) of programme implementation. Existing mechanisms, such as social safeguards within the scheme design to mitigate these risks may be assessed as well.
- f) Regional/State-level Variation: To assess whether the schemes' objectives have served the demands of various regions/states and the reasons for variations thereof. To document administrative reasons for variation in expenditure and health outcomes of various states.
- g) To identify and analyse the Most Significant Change (MSC) that every scheme has been able to achieve.
- h) To assess the operational readiness of all CSS Schemes in terms of institutional mechanisms at all levels, e.g. operating schemes in mission mode or through state health departments, fund flow (adequacy, regularity & timeliness) & utilization through public expenditure tracking, planning process (top-down and bottom-up), policy guidelines.
- i) The degree to which private sector resources and Public Private Partnership (PPP) has been leveraged in projects( if applicable )
- j) To identify and highlight scalable best practices and innovations, if any, and create case studies for further dissemination

# 2.3 Programme Harmonization:

- a. To provide recommendations based on the synthesis of sectoral and scheme-level analysis, on the need to continue the schemes in their existing form, modify, scale-up, scale-down or close down the schemes.
- b. To suggest revisions in the scheme/schemes design for the effective implementation in future, if modification is recommended.

# 2.4 Cross-sectional Thematic Assessment

The cross-sectional themes based on which the CSS scheme will be assessed may include

- Accountability and transparency
- Sustainable Development Goals (SDGs)



- Homeless/shelter-less/jobless individuals
- Competitive cities & agglomeration economy
- e-Governance
- Reforms for better implementation
- Climate resilience

#### 2.5 Prioritization of Schemes:

- i. For prioritization of schemes for evaluation, two parameters are to be taken into consideration:(i) duration of implementation, and (ii) budget allocation.
- ii. Based on duration of implementation, schemes can be classified into two categories: (a) those introduced prior to 15th Finance Commission cycle; and (b) those that were introduced during the 15th Finance Commission cycle. Schemes that were launched prior to 15th Finance Commission cycle (prior to 2021-22) are more amenable to full-scale evaluation. For those schemes that are introduced during the 15th Finance Commission cycle(between 2021-22 to 25-26), one needs to be cognizant that new schemes need time to be introduced, take off, and stabilize, and generally have to face a number of initiation challenges. This means, most of the schemes introduced in the 15th Finance Commission cycle have had only few years of full implementation, and therefore for these schemes a mid-term evaluation may be more relevant. Additionally, there are a few schemes that have been launched recently, which can be categorized as 'new' schemes, for which a limited assessment of their progress till date could be conducted after having an consultation with Consultant.
- iii. Schemes can also be classified based on the budget outlay. Out of the total five schemes, three schemes take up 93.5% of the CSS outlay from 2020-21 to 2024-25, while the two odd smaller schemes take up just about 6.4 The selected consultancy may confirm with the concerned Ministry the status of the scheme, and conduct a short analysis for the schemes that are proposed to be closed.

## 3. <u>Scope of Services</u>

#### 3.1 Reference period of the study

- i. 2019-20 to 2024-25 Secondary research for sectoral analysis and since inception for scheme level;
- ii. 2021-22 to 2023-24: for Primary research

#### 3.2 Meta-Analysis

- 3.2.1. The meta-analysis will involve review of
  - a. National, State Level and International sector and scheme documents; guidelines, MoUs and other associated documents.
  - b. Financial data on allocation and expenditures of schemes;
  - c. Annual reports of ministries for output and outcome assessment;



- d. Available evaluation reports done at National, state and district level;
- e. Annual progress reports and implementation documents to assess the institutional arrangements;
- f. CAG reports, Parliamentary Standing Committee Reports, Survey data, etc.
- g. Articles/research papers of peer-reviewed journals;
- h. MIS/Dashboards/Admin Data/Evaluation reports of any other scheme that directly/indirectly affects the outcome of the schemes.
- i. References of global/international best practices/case studies may be taken if required

#### 3.3 Preparation of evaluation matrix for sectoral and scheme analysis

The consultant will prepare the evaluation matrix addressing the evaluation objectives in consultation with DMEO. The matrix would map evaluation objectives with indicators, their data sources, collection methods/instruments and analysis approach to ensure credible and reliable findings for each objective. The matrix should assign appropriate weightage to the evaluation objectives to reflect their relative importance in the overall evaluation.

<u>3.4 Field Study - The field study would also include the following:</u>

- Designing of the discussions guides for focus group discussions, interview guides for in-depth interviews and structured questionnaires/schedules for household surveys.
- Preparation of the analysis plan
- Pre-testing and finalising the required tools in partnership with DMEO team
- Establishment of a managerial structure for field operations
- Recruitment of investigators and training/capacity building of the field investigators
- Putting in place appropriate IT hardware and application software for data collection and management.
- Collecting and compiling the quality data from selected areas.
- High quality data management and adherence to quality assurance mechanisms as per agreed protocols, plans and schedules.
- Collation and data cleaning
- Running data analysis and submitting cross-tabulations/summarizations
- Preparation of draft report and conducting stakeholder consultations
- Submission of final report and dissemination of the key findings
- Incorporating concurrent feedback into the workflow

During meta-analysis and field study, inputs from the concerned ministry/department may be incorporated for fine-tuning the methodology, preparation of analysis plan, listing of secondary data sources, investigator training and tool/questionnaire design.

### 4. <u>Primary Data Collection</u>



A mixed approach of Quantitative and Qualitative Analysis may be adopted. Quantitative Analysis may include the secondary data analysis. Also, the analysis and findings from secondary data be triangulated with household-level data. Additionally, the discussion guides/questionnaires for key informant interviews and household surveys should include the relevant data points pertaining to the evaluation of the schemes and the sector.

Key Informant Interviews & Focus Group Discussions - Herein, it is proposed that key informant interviews be held with officials from central ministries/departments, state-level implementing bodies and district and block, ULB level administration. Other stakeholders supporting implementation or indirectly involved in enabling the scheme's success, as well as opinion makers at the Block/ULB/ward level should also be interviewed. National level key informants should also include experts from recognized national level think tanks, institutions and prominent non-profit organisations. Additionally, focus group discussions will be conducted, mostly at block level (ULB/ward level(urban)) with diverse groups involving implementing stakeholders, opinion makers as well as selected beneficiaries.

Household Surveys - A selected sample of household surveys shall be conducted to assess the beneficiary-level perspective of the programmes. Since, various CSS schemes have different target groups, it is to be ensured that the sample and geography selection for Key Informant Interviews/household surveys factors in representation from each of the respective target groups/geographies.

# 4.1 Sampling

a. The sample design for a household survey must be stratified in such a way that the sample actually selected is spread over geographic sub-areas and population sub-groups properly. The size of the sample must take account of competing needs so that costs and precision are optimally balanced. Given all India nature of the CSS scheme implementation, the sampling methodology will involve multi-stage, stratified and clustered features. Given the sector level evaluation, the household surveys will have a general-purpose in scope, covering multiple topics for evaluation of schemes. The sample plan must make use of clusters of households in order to keep costs to a manageable level but at the same time it must avoid being overly clustered. Keeping in view time frame and other factors, a non-probability judgmental and/or purposive sampling will be followed. The sample size can be based on a comparatively small proportion of the target population focused on several subjects. The survey managers may decide to base the sample size on being able to measure, reliably, a characteristic held by certain percent of the population dependent upon budget considerations.

Entire country can be divided into 6 geographical zones i.e. (i) North & Central, (ii) South, (iii) East, (iv) West, (v) North-East and (vi) Northern Hilly states.

Zone-wise list of states are mentioned in the table below:

A minimum of 11 States and 1 Union Territory are to be selected, of which each zone must be represented by at least one State. The State/UT selection criterion is to be proposed by the Consultant as a part of the Methodology and Work Plan in Appen. Subsequently, all the cities/towns within a selected state can be classified into 5 strata based on scheme performance on key outcomes and a town/city be selected from each strata; thereby selecting about 60 cities/towns across 12 selected State/UT from 6 zones. Out of these 60 cities/towns, 12 (Category A) can be the Smart Cities selected in round 1 of challenge process of smart cities selection, which will also have AMRUT and other scheme implementation, additional 24 cities (Category B) can be the AMRUT Cities i.e. with all CSS schemes other than Smart Cities being implemented and the remaining 24 (Category C) will be the cities with only PMAY-Urban, NULM and Swachh Bharat (Urban) being implemented. Furthermore, using stratification, 3, 2 and 1 number of wards will be selected from each of the Category A, B and C cities respectively. This way, a total of 108 wards can be selected and lastly, within each ward, about 10 households covering eligible beneficiaries; both benefitted (e.g. 6-7 out of 10) and non- benefitted (e.g. 3-4 out of 10) can be interviewed.

Also, it should be ensured that Left Wing Extremism-affected (LWE) areas, aspirational districts and island areas are not inadvertently left out, if relevant.

However, it is important to note that <u>these numbers are indicative</u> and it is proposed that the <u>Consultant</u> <u>may suggest their methodology</u> best suited to meet the objectives of the evaluation. However, a minimum of about 200 tentative key informant interviews, about 50 focus group discussions and about 2100 household interviews should be conducted as a part of the field study.

# 4.2 Mechanisms to ensure Data Quality

A multi-pronged robust process for quality control needs to be followed during data collection. The following aspects need to considered:

a. Training and Screening Mechanism:



The field investigators to be engaged for conducting the survey & key informant interviews should have at least 3 years of experience in conducting similar surveys/interviews. 2-step training (classroom and then on-the-field training) should be conducted by the consultant for all field investigators. The consultant should put in place adequate screening mechanisms, so that only those surveyors who attain a certain level of understanding of the questionnaire would be deployed for the field survey.

b. Pilot for Survey:

It is recommended that pilots should be conducted on at least 2% of the sample size (spread in 3 zones in Inida )for both survey and KIIs to fine tune the inquiry tools. Similarly, pilot must be conducted for an adequate number of Key Informant Interviews/FGDs to fine tune the inquiry tools. A brief on the learnings from such a pilot exercise and subsequent improvements in the tools/questionnaires should also be shared with DMEO.

c. Adequate deployment of manpower:

The consultant should ensure that an adequate number of surveyors are deployed as a team for smooth collection of data in a particular district/block//ULB/ward(urban).

d. Data Validation:

100% data collected should be validated using a validation checklist. Missing data points should be collected. Data must also be collected in an ethical manner, i.e, in consideration of the respondents' privacy.

e. Data Verification:

In the case of survey, the consultant should ensure that at least 5% data verification is conducted physically. The consultant may additionally conduct back checks telephonically. The back checks and verifications should be evenly spread across the study area.

The supervisors are required to undertake surprise checks of the beneficiary surveys and confirmation from select KIIs about conduct of the interview (could be done telephonically).

f. Use of CAPI and Tracking System:

Use of mobile-based (CAPI), near real-time and geo-tagged data collection and validation tools should be done to ensure efficiency and accuracy in data collection. Access to tools and data should be provided to the authority.




# Section B: Skill Development

### 1. Background of the sector

The Indian economy at GDP of USD 3.7 trillion (estd. 2024) and an estimated growth rate of real GDP at 7.3% in 2023-24, finds its greatest strength in its working-age population1617. India is one of the youngest nations of world with more than 62% of its population falling within the working age group (15-59 years), with over 54% of the total population below 25 years of age <sup>18</sup>.

NITI Aayog's India @ 75 Strategy stated19 that by 2022-23, India needs to increase the proportion of formally skilled labor from the current 5.4 percent of India's workforce to at least 15 percent to harness the demographic advantage. Additionally, SDG 8 (Decent Work and Economic Growth) aims to promote sustained, inclusive, and sustainable economic growth, full and productive employment, and decent work for all. Further, the sub-targets within SDG 5(Gender Equality) and 10(Reduced Inequalities) underline the importance of gender equality and reducing income gaps by providing equal opportunities to all, regardless of age, gender, disability, race, ethnicity, religion, or origin.

The overview of the schemes covered under the Ministry of Skill Development and Entrepreneurship (MSDE) are given in the illustration below:



Government of India launched Skill India Mission in 2015 as a pivotal initiative towards transformation in skill sector with an objective to scale up skill development efforts by establishing an end-to-end outcome-focused implementation framework. In order to meet the mandate of Skill Indian Mission, the Ministry of Skill Development and Entrepreneurship (MSDE), implemented the various schemes/programmes including three major programmes namely; Acquisition and Knowledge Awareness for Livelihood Promotion (SANKALP), Skill Strengthening for Industrial

Value Enhancement (STRIVE) and Strengthening of Infrastructure for Institutional Training (SIIT). SANKALP, a World Bank-assisted project, focuses on developing the skilling ecosystem by strengthening institutional mechanisms, enhancing the quality and market relevance of short –term skill training, promoting inclusion and access for marginalized communities, and decentralizing skill planning. STRIVE, another World Bank-assisted project, focuses on improving the relevance and efficiency of long- term skills training provided through Industrial Training Institutes (ITIs) and apprenticeships. SIIT aims to enhance the existing infrastructure for skill development in the North Eastern States, districts affected by Left Wing Extremism (LWE), upgrading Polytechnic infrastructure, and transforming ITIs into model institutes.

In view of the above, a comprehensive study on Skill ecosystem were taken up to evaluate their relevance, achievements of objectives (effectiveness and impact), ease of implementation (efficiency), sustainability and inclusiveness (equity). A further and more comprehensive study on job and skill ecosystem to identify the structural gaps in the sector should be taken up with the design of alternative interventions, policies and initiatives. In this way, the study will enable assessment of CSS at schematic level for their rationalization and continuity beyond the 15th Finance Commission period.

tracking, policy guidelines and capacity building &training for the implementation of the schemes at central, state, and district level.

## 2.3 Programme Harmonization:

- a. To provide recommendations based on the synthesis of sectoral and scheme-level analysis, on the need to continue the schemes in their existing form, modify, scale-up, scale-down or close down the schemes
- b. To suggest revisions in the scheme/schemes design for the effective implementation in future, if modification is recommended.

## 2.4 Cross-sectional Thematic Assessment

The cross-sectional themes based on which each CSS scheme will be assessed may include:

- a. Accountability and transparency
- b. Direct/indirect employment generation
- c. Gender mainstreaming
- d. Sustainability
- e. Role of Tribal Sub-Plan (TSP) and Scheduled Caste Sub-Plan component of the scheme in mainstreaming of Tribal and Scheduled Caste population
- f. Use of IT/Technology in driving efficiency
- g. Stakeholder & beneficiary behavioral change
- h. Unlocking synergies with other government programmes
- i. Reforms and regulation for better implementation

## 2.5 Prioritization of Schemes:

For prioritization of schemes for evaluation, two parameters are to be taken into consideration: (1) duration of implementation, and (2) budget allocation.

- 1. Based on the duration of implementation, schemes can be classified into two categories: (a) those introduced prior to the 15th Finance Commission cycle; and (b) those that were introduced during the 15th Finance Commission cycle. Schemes that were launched prior to the 15th Finance Commission cycle (prior to 2019-20) are more amenable to full-scale evaluation. For those schemes that are introduced during the 15th Finance Commission cycle, one needs to be cognizant that new schemes need time to be introduced, take off, and stabilise, and generally have to face a number of initiation challenges. This means that most of the schemes introduced in the 15th Finance Commission cycle have had only a few years of full implementation, and therefore for these schemes, a mid-term evaluation may be more relevant. Additionally, there are a few schemes that have been launched recently, which can be categorised as 'new' schemes, for which a limited assessment of their progress to date could be conducted by the Consultant.
- 2. Schemes can also be classified based on the budget outlay. Out of the total three schemes, two schemes account for 80% of the CSS outlay from 2020-21 to 2024-25, while one scheme takes up just only about 20%.



3. In addition, there are certain schemes which are empowered through specific acts of legislation. Assuming that these schemes will continue, evaluation of these legislatively-backed schemes should focus on input and process insights for improving the outcomes and impact of these schemes.

## 3. <u>Scope of Services</u>

This evaluation study is expected to follow a mixed-method approach using both qualitative and quantitative analytical methods by emphasizing primary and secondary research. The study foresees an exhaustive review of secondary literature which will be validated with the primary data collected through survey. Also, the evidence from both should be triangulated.

## 3.1 Reference period of the study:

- 2019-20 to 2024-25 Secondary research for sectoral and since inception for scheme level
- 2021-22 to 2023-24: for Primary research

### 3.2. Meta-Analysis:

The meta-analysis will involve review of

- a. National, State Level and International sector and scheme documents; guidelines, MoUs and other associated documents.
- b. Financial data on allocation and expenditures of schemes;
- c. Annual reports of ministries for output and outcome assessment;
- d. Available evaluation reports done at National, state and district level;
- e. Annual progress reports and implementation documents to assess the institutional arrangements;
- f. CAG reports, Parliamentary Standing Committee Reports, Survey data, etc.
- g. Articles/research papers of peer-reviewed journals;
- h. MIS/Dashboards/Admin Data/Evaluation reports of any other scheme that directly/indirectly affects the outcome of the schemes.

#### 3.3 Preparation of evaluation matrix for sectoral and scheme analysis:

The consultant will prepare the evaluation matrix addressing the evaluation objectives in consultation with DMEO. The matrix would map evaluation objectives with indicators, their data sources, collection methods/instruments and analysis approach to ensure credible and reliable findings for each objective. The matrix should assign appropriate weightage to the evaluation objectives to reflect their relative importance in the overall evaluation.

#### 3.4. Field study:

The field study would also include the following:

a. Designing of the discussion guides for focus group discussions, interview guides for in-depth interviews and structured questionnaires/schedules for beneficiary surveys.



- b. Preparation of the analysis plan
- c. Pre-testing and finalising the required tools in partnership with DMEO team.
- d. Establishment of a managerial structure for field operations
- e. Recruitment of investigators and training/capacity building of the field investigators.
- f. Putting in place appropriate IT hardware and application software for data collection and management.
- g. Collecting and compiling the quality data from selected areas.
- h. High-quality data management and adherence to quality assurance mechanisms as per agreed protocols, plans and schedules.
- i. Collation and data cleaning
- j. Running data analysis and submitting cross-tabulations/summarizations.
- k. Preparation of draft evaluation report and conducting stakeholder consultations
- I. Submission of the final report and dissemination of the key findings
- m. Incorporating concurrent feedback into the workflow.

During meta-analysis and field study, inputs from the concerned ministry/department may be incorporated for fine-tuning the methodology, preparation of analysis plan, listing of secondary data sources, investigator training and tool/questionnaire design.

## 4. <u>Primary Data Collection</u>

A quantitative and qualitative study backed with extensive meta-analysis will be conducted to provide a sectoral assessment. The qualitative study will consist of two main components:

## 4.1.1 Key Informant Interviews & Focused Group Discussions

Herein, it is proposed that key informant interviews be held with officials from central ministries/departments, state-level implementing bodies and district and block level administration. Other stakeholders supporting implementation or indirectly involved in enabling the scheme's success, as well as opinion makers at the village level should also be interviewed (if applicable). National level key informants should also include experts from recognized national level think tanks, institutions and prominent non-profit organizations.

Additionally, focus group discussions will be conducted mostly at block and village level (if applicable) with diverse groups involving implementing stakeholders, opinion makers as well as selected beneficiaries.

## 4.1.2 Enterprise/ Establishment Survey

A selected sample of enterprises/units shall be surveyed to assess the impact of the programs. Enterprises to be covered can be stratified as per the standard definitions of micro, small, medium and large enterprise as per Ministry of micro, small and medium enterprise. Since a large number of enterprises are unregistered, due representation of the same should be ensured in the enterprise survey.

## 4.1.3 Beneficiary Surveys



A selected sample of workers shall be conducted to assess the beneficiary-level impact of the programs. Since, various CSS schemes have different target groups; it is to be ensured that the sample & geography selection for key informant interviews/ beneficiary surveys factors in representation from each of the respective target groups/geographies.

# 4.2. Sampling

The sample design for the survey must be stratified in such a way that the sample actually selected is spread over geographic sub-areas and population sub-groups properly. The size of the sample must take account of competing needs so that costs and precision are optimally balanced. Given all India nature of the CSS scheme implementation, the sampling methodology will involve multi-stage, stratified and clustered features. In view of the sector level evaluation, the beneficiary surveys will have a general-purpose in scope, covering multiple topics of interest to the government<del>.</del> The sample plan must make use of clusters of Enterprise/Establishment in order to keep costs to a manageable level but at the same time it must avoid being overly clustered. Keeping in view time frame and other factors, a non-probability judgmental and/or purposive sampling will be followed. The sample size can be based on a comparatively small proportion of the target population focused on several subjects. The survey managers may decide to base the sample size on being able to measure, reliably, a characteristic held by certain percentage of the population dependent upon budget considerations.

Entire country can be divided into 6 geographical zones i.e. (i) North & Central, (ii) South, (iii) East, (iv) West, (v) North-East and (vi) Northern Hilly states.

Zone-wise list of states are mentioned in the table below:

A minimum of 11 States and 1 Union Territory are to be selected, of which each zone must be represented by at least one State. Subsequently, within each selected State/UT, all the districts will be classified into 2 to 3strata based on key sectoral performance/index and a district will be selected from each strata; thereby taking the total no. of districts selected to around 30-35. From each



selected district, institution/Enterprise will be selected based on the population proportion of the district. Hence, within each selected Institution/Enterprise from the district, beneficiaries will be selected based on the size of the selected institution/Enterprise.

Hence, within each selected district, beneficiaries will be selected from block/village level (if applicable for certain schemes). Also, it should be ensured that Left Wing Extremism-affected (LWE) areas, aspirational districts and island areas are not inadvertently left out, if relevant

However, it is important to note that these numbers are indicative, and it is proposed that the Consultant may suggest their methodology best suited to meet the objectives of the evaluation. However, a minimum of about 250 key informant interviews, about 50 focus group discussions, about 860 beneficiary surveys should be conducted as a part of the field study.

### 4.3. Mechanisms to ensure Data Quality

A multi-pronged robust process for quality control needs to be followed during data collection. The following aspects need to considered:

i. Training and Screening Mechanism:

The field investigators to be engaged for conducting the survey & key informant interviews should have at least 3 years of experience in conducting similar surveys/interviews. 2-step training (classroom and then on-the-field training) should be conducted by the consultant for all field investigators. The consultant should put in place adequate screening mechanisms, so that only those surveyors who attain a certain level of understanding of the questionnaire would be deployed for the field survey.

ii. Pilot for Survey:

It is recommended that pilots should be conducted on at least 2% of the sample size for both survey and KIIs to fine tune the inquiry tools. Similarly, pilot must be conducted for an adequate number of Key Informant Interviews/FGDs to fine tune the inquiry tools. A brief on the learnings from such a pilot exercise and subsequent improvements in the tools/questionnaires should also be shared with DMEO.

iii. Adequate deployment of manpower:

The consultant should ensure that an adequate number of surveyors are deployed as a team for smooth collection of data in a particular district/block/village.

iv. Data Validation:

100% data collected should be validated using a validation checklist. Missing data points should be collected. Data must also be collected in an ethical manner, i.e, in consideration of the respondents' privacy.

v. Data Verification:



In the case of survey, the consultant should ensure that at least 5% data verification is conducted physically. The consultant may additionally conduct back checks telephonically. The back checks and verifications should be evenly spread across the study area.

The supervisors are required to undertake surprise checks of the beneficiary surveys and confirmation from select KIIs about conduct of the interview (could be done telephonically).

vi. Use of CAPI and Tracking System:

Use of mobile-based (CAPI), near real-time and geo-tagged data collection and validation tools should be done to ensure efficiency and accuracy in data collection. Access to tools and data should be provided to the authority.

### AGREEMENT

Consultancy for Evaluation of Centrally Sponsored Schemes in Package 4 – Urban Transformation & Skill Development

### WHEREAS

- (A) The Authority vide its Request for Proposal for conducting an Evaluation Study (hereinafter called the "Consultancy") for the Evaluation of Centrally Sponsored Schemes in Package 4
   Urban Transformation & Skill Development (hereinafter called the "Project");
- (B) the Consultant submitted its proposals for the aforesaid work, whereby the Consultant represented to the Authority that it had the required professional skills, and in the said proposals the Consultant also agreed to provide the Services to the Authority on the terms and conditions as set forth in the RFP and this Agreement; and
- (C) the Authority, on acceptance of the aforesaid proposals of the Consultant, awarded the Consultancy to the Consultant vide its Letter of Award dated ...... (the "LOA"); and
- (D) in pursuance of the LOA, the parties have agreed to enter into this Agreement.

NOW, THEREFORE, the parties hereto hereby agree as follows:

### 1. General

- 1.1. Definitions and Interpretation
- 1.1.1. The words and expressions beginning with capital letters and defined in this Agreement shall, unless the context otherwise requires, have the meaning hereinafter respectively assigned to them:
  - (a) "Agreement" means this Agreement, together with all the Annexes;
  - (b) "Agreement Value" shall have the meaning set forth in Clause 6.1.2;
  - (c) "Applicable Laws" means the laws and any other instruments having the force of law in India as they may be issued and in force from time to time;
  - (d) "Confidential Information" shall have the meaning set forth in Clause 3.3;
  - (e) "Conflict of Interest" shall have the meaning set forth in Clause 3.2 read with the provisions of RFP;
  - (f) "Dispute" shall have the meaning set forth in Clause 9.2.1;



- (g) "Effective Date" means the date on which this Agreement comes into force and effect pursuant to Clause 2.1;
- (h) "Government" means the Government of .....;
- (i) "INR, Re. or ₹" means Indian Rupees;
- (j) "Member", in case the Consultant consists of a joint venture or consortium of more than one entity, means any of these entities, and "Members" means all of these entities;
- (k) "Party" means the Authority or the Consultant, as the case may be, and Parties means both of them;
- (I) "Personnel" means persons hired by the Consultant as employees and assigned to the performance of the Services or any part thereof;
- (m) "RFP" means the Request for Proposal document in response to which the Consultant's proposal for providing Services was accepted;
- (n) "Services" means the work to be performed by the Consultant pursuant to this Agreement, as described in the Terms of Reference hereto;
- (o) "Third Party" means any person or entity other than the Government, the Authority, the Consultant.

All terms and words not defined herein shall, unless the context otherwise requires, have the meaning assigned to them in the RFP.

- 1.1.2. The following documents along with all addenda issued thereto shall be deemed to form and be read and construed as integral parts of this Agreement and in case of any contradiction between or among them the priority in which a document would prevail over another would be as laid down below beginning from the highest priority to the lowest priority:
  - (a) Agreement;
  - (b) Annexes of Agreement;
  - (c) RFP; and
  - (d) Letter of Award.
- 1.2. Relation between the Parties

Nothing contained herein shall be construed as establishing a relation of master and servant or of agent and principal as between the Authority and the Consultant. The Consultant shall, subject to this Agreement, have complete charge of Personnel performing the Services and shall be fully responsible for the Services performed by them or on their behalf hereunder.



1.3. Rights and obligations

The mutual rights and obligations of the Authority and the Consultant shall be as set forth in the Agreement, in particular:

- (a) the Consultant shall carry out the Services in accordance with the provisions of the Agreement; and
- (b) the Authority shall make payments to the Consultant in accordance with the provisions of the Agreement.
- 1.4. Governing law and jurisdiction

This Agreement, its meaning and interpretation, and the relation between the parties shall be governed by the Laws of India for the time being in force. Irrespective of the place of delivery, the place of performance or the place of payments under the agreement, the agreement shall be deemed to have been made at the place from which the Letter of Award (LoA or Agreement, in absence of LoA) has been issued. Unless otherwise specified in the agreement, the courts of such a place shall alone have jurisdiction to decide any dispute arising out or in respect of the agreement.

1.5. Language

All notices required to be given by one Party to the other Party and all other communications, documentation and proceedings which are in any way relevant to this Agreement shall be in writing and in English language.

1.6. Table of contents and headings

The table of contents, headings or sub-headings in this Agreement are for convenience of reference only and shall not be used in, and shall not affect, the construction or interpretation of this Agreement.

1.7. Notices

Any notice or other communication to be given by any Party to the other Party under or in connection with the matters contemplated by this Agreement shall be in writing and shall:

- (a) in the case of the Consultant, be given by e-mail and by letter delivered by hand to the address given and marked for attention of the Consultant's Representative set out below in Clause 1.10\_or to such other person as the Consultant may from time to time designate by notice to the Authority; provided that notices or other communications to be given to an address outside the city specified in Sub-clause (b) below may, if they are subsequently confirmed by sending a copy thereof by registered acknowledgement due, air mail or by courier, be sent by e-mail to the number as the Consultant may from time to time specify by notice to the Authority;
- (b) in the case of the Authority, be given by e-mail and by letter delivered by hand and be addressed to the Authority with a copy delivered to the Authority Representative set out below in Clause 1.10 or to such other person as the Authority may from time to time designate by notice to the Consultant; provided that if the Consultant does not have an office in the



same city as the Authority's office, it may send such notice by e-mail and by registered acknowledgement due, air mail or by courier; and

(c) any notice or communication by a Party to the other Party, given in accordance herewith, shall be deemed to have been delivered when in the normal course of post it ought to have been delivered and in all other cases, it shall be deemed to have been delivered on the actual date and time of delivery; provided that in the case of e-mail, it shall be deemed to have been delivered on the working days following the date of its delivery.

### 1.8. Location

The Services shall be performed at the site of the Project in accordance with the provisions of RFP and at such locations as are incidental thereto, including the offices of the Consultant.

1.9. Authority of Member-in-charge

In case the Consultant consists of a consortium of more than one entity, the Parties agree that the Lead Member shall act on behalf of the Members in exercising all the Consultant's rights and obligations towards the Authority under this Agreement, including without limitation the receiving of instructions and payments from the Authority.

- 1.10. Authorised Representatives
  - 1.10.1. Any action required or permitted to be taken, and any document required or permitted to be executed, under this Agreement by the Authority or the Consultant, as the case may be, may be taken or executed by the officials specified in this Clause 1.10.
  - 1.10.2. The Authority may, from time to time, designate one of its officials as the Authority Representative. Unless otherwise notified, the Authority Representative shall be:

1.10.3. The Consultant may designate one of its employees as Consultant's Representative. Unless otherwise notified, the Consultant's Representative shall be:

### 1.11. Taxes and duties

Unless otherwise specified in the Agreement, the Consultant shall pay all such taxes, duties, fees and other impositions as may be levied under the Applicable Laws and the Authority shall perform such duties in regard to the deduction of such taxes as may be lawfully imposed on it

### 1.12. Communications

All communications under the agreement shall be served by the parties to each other in writing, in the agreement's language, and served in a manner customary and acceptable in business and commercial transactions. The effective date of such communications shall be either the date when delivered to the recipient or the effective date mentioned explicitly in the communication, whichever is later. No communication shall amount to an amendment of the terms and conditions of the agreement, except a formal letter of amendment of the agreement expressly so designated.

### 2. Commencement, Completion and Termination of Agreement

2.1. Effectiveness of Agreement

This Agreement shall come into force and effect on the date of this Agreement (the "Effective Date").

2.2. Commencement of Services

The Consultant shall commence the Services within a period of 7 (seven) days from the Effective Date, unless otherwise agreed by the Parties.

2.3. Termination of Agreement for failure to commence Services

If the Consultant does not commence the Services within the period specified in Clause 2.2 above, the Authority may, by not less than 2 (two) weeks' notice to the Consultant, declare this Agreement to be null and void, and in the event of such a declaration, the Authority reserves the right to take action as per the Bid Security or Bid Security Declaration Form.

2.4. Expiry of Agreement

Unless terminated earlier according to Clauses 2.3 or 2.9, this Agreement will expire under two conditions (i) 90 (ninety) days after delivering the final report (refer to section -C Other Guidelines clause 2 (iv) of the Terms of reference) to the Authority. or (ii) three years from the effective date, whichever occurs first, unless extended by mutual consent of the parties.

- 2.5. Entire Agreement
- 2.5.1. This Agreement and the Annexes together constitute a complete and exclusive statement of the terms of the agreement between the Parties on the subject hereof, and no amendment or modification hereto shall be valid and effective unless such modification or amendment is agreed to in writing by the Parties and duly executed by persons especially empowered in this behalf by the respective Parties. All prior written or oral understandings, offers or other communications of every kind pertaining to this Agreement are abrogated and withdrawn;



provided, however, that the obligations of the Consultant arising out of the provisions of the RFP shall continue to subsist and shall be deemed to form part of this Agreement.

- 2.5.2. Without prejudice to the generality of the provisions of Clause 2.5.1, on matters not covered by this Agreement, the provisions of RFP shall apply.
- 2.6. Modification of Agreement

There shall be no modification in the terms and conditions of this Agreement unless the reasons are beyond the control of both parties i.e. the Applicant and the Authority. In no circumstances, the cost should be higher than the agreement cost due to modifications in the terms and conditions.

- 2.7. Force Majeure
- 2.7.1. Definition
  - (a) For the purposes of this Agreement, "Force Majeure" means an event which is beyond the reasonable control of a Party, and which makes a Party's performance of its obligations hereunder impossible or so impractical as reasonably to be considered impossible in the circumstances, and includes, but is not limited to, war, riots, civil disorder, earthquake, fire, explosion, storm, flood or other adverse weather conditions, strikes, lockouts or other industrial action (except where such strikes, lockouts or other industrial action are within the power of the Party invoking Force Majeure to prevent), confiscation or any other action by government agencies.
  - (b) Force Majeure shall not include (i) any event which is caused by the negligence or intentional action of a Party or such Party's agents or employees, nor (ii) any event which a diligent Party could reasonably have been expected to both (A) take into account at the time of the conclusion of this Agreement, and (B) avoid or overcome in the carrying out of its obligations hereunder.
  - (C) Force Majeure shall not include insufficiency of funds or failure to make any payment required hereunder.
- 2.7.2. No breach of Agreement

The failure of a Party to fulfill any of its obligations hereunder shall not be considered to be a breach of, or default under, this Agreement insofar as such inability arises from an event of Force Majeure, provided that the Party affected by such an event has taken all reasonable precautions, due care and reasonable alternative measures, all with the objective of carrying out the terms and conditions of this Agreement.

- 2.7.3. Measures to be taken
  - (a) A Party affected by an event of Force Majeure shall take all reasonable measures to remove such Party's inability to fulfill its obligations hereunder with a minimum of delay.
  - (b) A Party affected by an event of Force Majeure shall notify the other Party of such event as soon as possible, and in any event not later than 14 (fourteen) days following the occurrence of such event, providing evidence of the nature and cause of such event, and shall similarly give notice of the restoration of normal conditions as soon as possible.



- (C) The Parties shall take all reasonable measures to minimise the consequences of any event of Force Majeure.
- 2.7.4. Extension of time

Any period within which a Party shall, pursuant to this Agreement, complete any action or task, shall be extended for a period equal to the time during which such Party was unable to perform such action as a result of Force Majeure.

2.7.5. Consultation

Not later than 30 (thirty) days after the Consultant has, as the result of an event of Force Majeure, become unable to perform a material portion of the Services, the Parties shall consult with each other with a view to agreeing on appropriate measures to be taken in the circumstances.

2.8. Suspension of Agreement

The Authority may, by written notice of suspension to the Consultant, suspend all payments to the Consultant hereunder if the Consultant shall be in breach of this Agreement or shall fail to perform any of its obligations under this Agreement, including the carrying out of the Services; provided that such notice of suspension (i) shall specify the nature of the breach or failure, and (ii) shall provide an opportunity to the Consultant to remedy such breach or failure within a period not exceeding 21 (twenty one) days after receipt by the Consultant of such notice of suspension.

- 2.9. Termination of Agreement
- 2.9.1. By the Authority

The Authority may, by not less than 21 (twenty) days' written notice of termination to the Consultant, such notice to be given after the occurrence of any of the events specified in this Clause 2.9.1, terminate this Agreement if:

- (a) the Consultant fails to remedy any breach hereof or any failure in the performance of its obligations hereunder, as specified in a notice of suspension pursuant to Clause 2.8 hereinabove, within 21 (twenty-one) days of receipt of such notice of suspension or within such further period as the Authority may have subsequently granted in writing;
- (b) the Consultant becomes insolvent or bankrupt or enters into any agreement with its creditors for relief of debt or take advantage of any law for the benefit of debtors or goes into liquidation or receivership whether compulsory or voluntary;
- (c) the Consultant fails to comply with any final decision reached as a result of arbitration proceedings pursuant to Clause 9 hereof;
- (d) the Consultant submits to the Authority a statement which has a material effect on the rights, obligations or interests of the Authority and which the Consultant knows to be false;



- (e) any document, information, data or statement submitted by the Consultant in its Proposals, based on which the Consultant was considered eligible or successful, is found to be false, incorrect or misleading;
- (f) as the result of Force Majeure, the Consultant is unable to perform a material portion of the Services for a period of not less than 60 (sixty) days; or
- (g) the Authority, in its sole discretion and for any reason whatsoever, decides to terminate this Agreement.
- 2.9.2. By the Consultant

The Consultant may, by not less than 30 (thirty) days' written notice to the Authority, such notice to be given after the occurrence of any of the events specified in this Clause 2.9.2, terminate this Agreement if:

- (a) the Authority fails to pay any money due to the Consultant pursuant to this Agreement and not subject to dispute pursuant to Clause 9 hereof within 45 (forty-five) days after receiving written notice from the Consultant that such payment is overdue;
- (b) the Authority is in material breach of its obligations pursuant to this Agreement and has not remedied the same within 45 (forty-five) days (or such longer period as the Consultant may have subsequently granted in writing) following the receipt by the Authority of the Consultant's notice specifying such breach;
- (C) as the result of Force Majeure, the Consultant is unable to perform a material portion of the Services for a period of not less than 60 (sixty) days; or
- (d) the Authority fails to comply with any final decision reached as a result of arbitration pursuant to Clause 9 hereof.
- 2.9.3. Cessation of rights and obligations

Upon termination of this Agreement pursuant to Clauses 2.3 or 2.9 hereof, or upon expiration of this Agreement pursuant to Clause 2.4 hereof, all rights and obligations of the Parties hereunder shall cease, except (i) such rights and obligations as may have accrued on the date of termination or expiration, or which expressly survive such Termination; (ii) the obligation of confidentiality set forth in Clause 3.3 hereof; (iii) the Consultant's obligation to permit inspection, copying and auditing of such of its accounts and records set forth in Clause 3.6, as relate to the Consultant's Services provided under this Agreement; and (iv) any right or remedy which a Party may have under this Agreement or the Applicable Law.

2.9.4. Cessation of Services

Upon termination of this Agreement by notice of either Party to the other pursuant to Clauses 2.9.1 or 2.9.2 hereof, the Consultant shall, immediately upon dispatch or receipt of such notice, take all necessary steps to bring the Services to a close in a prompt and orderly manner and shall make every reasonable effort to keep expenditures for this purpose to a minimum. With respect to documents prepared by the Consultant they shall proceed as provided respectively by Clauses 3.9 hereof.



### 2.9.5. Payment upon Termination

Upon termination of this Agreement pursuant to Clauses 2.9.1 or 2.9.2 hereof, the Authority shall make the following payments to the Consultant (after offsetting against these payments any amount that may be due from the Consultant to the Authority):

- (i) remuneration pursuant to Clause 6 hereof for Services satisfactorily performed prior to the date of termination;
- (ii) reimbursable expenditures pursuant to Clause 6 hereof for expenditures actually incurred prior to the date of termination; and
- (iii) except in the case of termination pursuant to sub-clauses (a) through (e) of Clause 2.9.1 hereof, reimbursement of any reasonable cost incidental to the prompt and orderly termination of the Agreement including the cost of the return travel of the Consultant's personnel.

### 2.9.6. Disputes about Events of Termination

If either Party disputes whether an event specified in Clause 2.9.1 or in Clause 2.9.2 hereof has occurred, such Party may, within 30 (thirty) days after receipt of notice of termination from the other Party, refer the matter to arbitration pursuant to Clause 9\_hereof, and this Agreement shall not be terminated on account of such event except in accordance with the terms of any resulting arbitral award.

### 3. Obligations of the Consultant

- 3.1. General
- 3.1.1. Standards of Performance

The Consultant shall perform the Services and carry out its obligations hereunder with all due diligence, efficiency and economy, in accordance with generally accepted professional techniques and practices, and shall observe sound management practices, and employ appropriate advanced technology and safe and effective equipment, machinery, materials and methods. The Consultant shall always act, in respect of any matter relating to this Agreement or to the Services, as a faithful adviser to the Authority, and shall at all times support and safeguard the Authority's legitimate interests in any dealings with Third Parties.

### 3.1.2. Terms of Reference

The scope of services to be performed by the Consultant is specified in the Terms of Reference (the "TOR") at Annex-1 of this Agreement. The Consultant shall provide the Deliverables specified therein in conformity with the time schedule stated therein.

### 3.1.3. Applicable Laws

The Consultant shall perform the Services in accordance with the Applicable Laws and shall take all practicable steps to ensure that any Personnel and agents of the Consultant, comply with the Applicable Laws.

3.2. Conflict of Interest



- 3.2.1. The Consultant shall not have a Conflict of Interest and any breach hereof shall constitute a breach of the Agreement.
- 3.2.2. Consultant and Affiliates not to be otherwise interested in the Project

The Consultant agrees that, during the term of this Agreement and after its termination, the Consultant or any Associate thereof and any entity affiliated with the Consultant shall be disqualified from providing goods, works, services, loans or equity for any project resulting from or closely related to the Services and any breach of this obligation shall amount to a Conflict of Interest; provided that the restriction herein shall not apply after a period of five years from the completion of this assignment or to consulting assignments granted by banks/ lenders at any time; provided further that this restriction shall not apply to consultancy/ advisory services provided to the Authority in continuation of this Consultancy or to any subsequent consultancy/ advisory services provided to the Authority advisory services provided to the Consultant shall include a partner in the Consultant's firm or a person who holds more than 5% (five per cent) of the subscribed and paid up share capital of the Consultant, as the case may be, and any Associate thereof.

3.2.3. Prohibition of conflicting activities

Neither the Consultant nor its Personnel of either of them shall engage, either directly or indirectly, in any of the following activities:

- (a) during the term of this Agreement, any business or professional activities which would conflict with the activities assigned to them under this Agreement;
- (b) after the termination of this Agreement, such other activities as may be specified in the Agreement; or
- (C) at any time, such other activities as have been specified in the RFP as Conflict of Interest.
- 3.2.4. Consultant not to benefit from commissions, discounts, etc.

The remuneration of the Consultant pursuant to Clause 6 hereof shall constitute the Consultant's sole remuneration in connection with this Agreement or the Services and the Consultant shall not accept for its own benefit any trade commission, discount or similar payment in connection with activities pursuant to this Agreement or to the Services or in the discharge of its obligations hereunder, and the Consultant shall use its best efforts to ensure that its Personnel and agents shall not receive any such additional remuneration.

3.2.5. The Consultant and its Personnel shall observe the highest standards of ethics and shall not have engaged in and shall not hereafter engage in any corrupt practice, fraudulent practice, coercive practice, anti-competitive practice, conflict of interest, obstructive practice. Notwithstanding anything to the contrary contained in this Agreement, the Authority shall be entitled to terminate this Agreement forthwith by a communication in writing to the Consultant, without being liable in any manner whatsoever to the Consultant, if it determines that the Consultant has, directly or indirectly or through an agent, engaged in any Prohibited Practices in the Selection Process or before or after entering into of this Agreement. In such an event, the Authority shall forfeit and appropriate the performance security, if any, as mutually agreed genuine pre-estimated compensation and damages payable to the Authority



towards, *inter alia*, the time, cost and effort of the Authority, without prejudice to the Authority's any other rights or remedy hereunder or in law.


- 3.2.6. Without prejudice to the rights of the Authority under Clause 3.2.5 above and the other rights and remedies which the Authority may have under this Agreement, if the Consultant is found by the Authority to have directly or indirectly or through an agent, engaged or indulged in any Prohibited Practices, during the Selection Process or before or after the execution of this Agreement, the Consultant shall not be eligible to participate in any tender or RFP issued during a period of 2 (two) years from the date the Consultant is found by the Authority to have directly or through an agent, engaged or indulged in any Prohibited Practices.
- 3.2.7. For the purposes of Clauses 3.2.5 and 3.2.6, the following terms shall have the meaning hereinafter respectively assigned to them:
  - (a) "corrupt practice" means making an offer, solicitation or acceptance of a bribe, reward or gift or any material benefit in exchange for an unfair advantage in the Procurement Process or to otherwise influence the Procurement Process
  - (b) "fraudulent practice" means any omission or misrepresentation that may mislead or attempt to mislead so that financial or other benefits may be obtained or an obligation avoided. Such practices include a false declaration or false information for participation in a Procurement Process or to secure a Contract, or in the execution of the agreement;
  - (C) "coercive practice" means harming or threatening to harm persons or their property to influence their participation in the Procurement Process or affect the execution of the agreement
  - (d) "Anti-competitive practice" means any collusion, Proposal-rigging or anti-competitive arrangement, or any other practice including cartels coming under the purview of the Competition Act, 2002, between two or more Applicants, with or without the knowledge of the Authority, that may impair the transparency, fairness, and the progress of the Procurement Process or to establish Proposal prices at artificial, non-competitive levels
  - (e) Conflict of interest" means participation by a bidding firm or any of its affiliates who are either involved in the Consultancy Contract to which this procurement is linked; if they are part of more than one Proposal in the procurement; or if their personnel have a relationship or financial or business transactions with any official of Authority who are directly or indirectly related to tender or execution process of contract; or improper use of information obtained by the (prospective) Applicant from the Authority with an intent to gain unfair advantage in the Procurement Process or for personal gain
  - (f) "Obstructive practice" means materially impede Authority's investigation into allegations of one or more of the above-mentioned prohibited practices either by deliberately destroying, falsifying, altering; or concealing evidence material to the investigation; or by making false statements to investigators and/ or by coercive practices mentioned above, to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation, or by impeding the Authority's rights of an audit or access to information.
- 3.3. Confidentiality



The Consultant, and its Personnel of either of them shall not, either during the term or within two years after the expiration or termination of this Agreement disclose any proprietary information, including information relating to reports, data, drawings, design software or other material, whether written or oral, in electronic or magnetic format, and the contents thereof; and any reports, digests or summaries created or derived from any of the foregoing that is provided by the Authority to the Consultant, and its Personnel; any information provided by or relating to the Authority, its technology, technical processes, business affairs or finances or any information relating to the Authority's employees, officers or other professionals or suppliers, customers, or contractors of the Authority; and any other information which the Consultant is under an obligation to keep confidential in relation to the Project, the Services or this Agreement ("Confidential Information"), without the prior written consent of the Authority.

Notwithstanding the aforesaid, the Consultant, and its Personnel of either of them may disclose Confidential Information to the extent that such Confidential Information:

- was in the public domain prior to its delivery to the Consultant, and its Personnel of either of them or becomes a part of the public knowledge from a source other than the Consultant, its Sub-Consultants and the Personnel of either of them;
- (ii) was obtained from a third party with no known duty to maintain its confidentiality;
- (iii) is required to be disclosed by Applicable Laws or judicial or administrative or arbitral process or by any governmental instrumentalities, provided that for any such disclosure, the Consultant, and its Personnel of either of them shall give the Authority, prompt written notice, and use reasonable efforts to ensure that such disclosure is accorded confidential treatment; and
- (iv) is provided to the professional advisers, agents, auditors or representatives of the Consultant or its Personnel of either of them, as is reasonable under the circumstances; provided, however, that the Consultant or its Personnel of either of them, as the case may be, shall require their professional advisers, agents, auditors or its representatives, to undertake in writing to keep such Confidential Information, confidential and shall use its best efforts to ensure compliance with such undertaking.
- 3.4. Liability of the Consultant
- 3.4.1 The Consultant's liability under this Agreement shall be determined by the Applicable Laws and the provisions hereof.
- 3.4.2 The Consultant shall, subject to the limitation specified in Clause 3.4.3, be liable to the Authority for any direct loss or damage accrued or likely to accrue due to deficiency in Services rendered by it.
- 3.4.3 The Parties hereto agree that in case of negligence or wilful misconduct on the part of the Consultant or on the part of any person or firm acting on behalf of the Consultant in carrying out the Services, the Consultant, with respect to damage caused to the Authority's property, shall not be liable to the Authority:





- (i) for any indirect or consequential loss or damage; and
- (ii) for any direct loss or damage that exceeds (a) the Agreement Value set forth in Clause 6.1.2 of this Agreement, or (b) the proceeds the Consultant may be entitled to receive from any insurance maintained by the Consultant to cover such a liability in accordance with Clause 3.5.1, whichever of (a) or (b) is higher.
- 3.4.4 This limitation of liability specified in Clause 3.4.3 shall not affect the Consultant's liability, if any, for damage to Third Parties caused by the Consultant or any person or firm acting on behalf of the Consultant in carrying out the Services subject, however, to a limit equal to 3 (three) times the Agreement Value.
- 3.5. Insurance to be taken out by the Consultant
- 3.5.1. The Consultant shall, for the duration of this Agreement, take out and maintain, at its own cost, but on terms and conditions approved by the Authority, insurance against the risks, and for the coverages, as stipulated in the contract or any applicable law including Labour Codes; and at the Authority's request, shall provide evidence to the Authority showing that such insurance has been taken out and maintained and that the current premiums have been paid.
  - 3.6. Accounting, inspection and auditing

The Consultant shall:

- (a) keep accurate and systematic accounts and records in respect of the Services provided under this Agreement, in accordance with internationally accepted accounting principles and in such form and detail as will clearly identify all relevant time charges and cost, and the basis thereof (including the basis of the Consultant's costs and charges); and
- (b) permit the Authority or its designated representative periodically, and up to one year from the expiration or termination of this Agreement, to inspect the same and make copies thereof as well as to have them audited by auditors appointed by the Authority.
- 3.7. Consultant's actions requiring the Authority's prior approval

The Consultant shall obtain the Authority's prior approval in writing before taking any of the following actions:

- (a) appointing such members of the Professional Personnel as are not listed in Annex-2.
- (b) any other action that is specified in this Agreement.
- 3.8. Reporting obligations

The Consultant shall submit to the Authority the reports and documents specified in the Agreement, in the form, in the numbers and within the time periods set forth therein.

- 3.9. Documents prepared by the Consultant to be property of the Authority
- 3.9.1. All plans, drawings, specifications, designs, reports and other documents (collectively referred to as "Consultancy Documents") prepared by the Consultant (or by the Sub-



Consultants or any Third Party) in performing the Services shall become and remain the property of the Authority, and all intellectual property rights in such Consultancy Documents shall vest with the Authority. Any Consultancy Document, of which the ownership or the intellectual property rights do not vest with the Authority under law, shall automatically stand assigned to the Authority as and when such Consultancy Document is created and the Consultant agrees to execute all papers and to perform such other acts as the Authority may deem necessary to secure its rights herein assigned by the Consultant.

- 3.9.2. The Consultant shall, not later than termination or expiration of this Agreement, deliver all Consultancy Documents to the Authority, together with a detailed inventory thereof. The Consultant may retain a copy of such Consultancy Documents. The Consultant, or a Third Party shall not use these Consultancy Documents for purposes unrelated to this Agreement without the prior written approval of the Authority.
- 3.9.3. The Consultant shall hold the Authority harmless and indemnified for any losses, claims, damages, expenses (including all legal expenses), awards, penalties or injuries (collectively referred to as 'Claims') which may arise from or due to any unauthorised use of such Consultancy Documents, or due to any breach or failure on part of the Consultant or a Third Party to perform any of its duties or obligations in relation to securing the aforementioned rights of the Authority.
- 3.10. Providing access to Project Office and Personnel

The Consultant shall ensure that the Authority, and officials of the Authority having authority from the Authority, are provided unrestricted access to the Project Office and to all Personnel during office hour. The Authority's official, who has been authorised by the Authority in this behalf, shall have the right to inspect the Services in progress, interact with Personnel of the Consultant and verify the records relating to the Services for his satisfaction.

3.11. Accuracy of Documents

The Consultant shall be responsible for accuracy of the data collected by it directly or procured from other agencies/authorities, the designs, drawings, estimates and all other details prepared by it as part of these services. Subject to the provisions of Clause 3.4, it shall indemnify the Authority against any inaccuracy in its work which might surface during implementation of the Project, if such inaccuracy is the result of any negligence or inadequate due diligence on part of the Consultant or arises out of its failure to conform to good industry practice. The Consultant shall also be responsible for promptly correcting, at its own cost and risk, the drawings including any re-survey / investigations.

### 4. Consultant's Personnel

4.1. General

The Consultant shall employ and provide such qualified and experienced Personnel as may be required to carry out the Services.

- 4.2. Deployment of Personnel
- 4.2.1. The designations, names and the estimated periods of engagement in carrying out the Services by each of the Consultant's Personnel are described in Annex-2 of this Agreement.



The estimate of Personnel costs and person day rates are specified in Annex-3 of this Agreement.

- 4.2.2. Adjustments with respect to the estimated periods of engagement of Personnel set forth in the aforementioned Annex-3 may be made by the Consultant by written notice to the Authority, provided that: (i) such adjustments shall not alter the originally estimated period of engagement of any individual by more than 20% (twenty per cent) or one week, whichever is greater, and (ii) the aggregate of such adjustments shall not cause payments under the Agreement to exceed the Agreement Value set forth in Clause 6.1.2 of this Agreement. Any other adjustments shall only be made with the written approval of the Authority.
  - 4.3. Approval of Personnel
- 4.3.1. The Professional Personnel listed in Annex-2 of the Agreement are hereby approved by the Authority. No other Professional Personnel shall be engaged without prior approval of the Authority.
- 4.3.2. If the Consultant hereafter proposes to engage any person as Professional Personnel, it shall submit to the Authority its proposal along with a CV of such person in the form provided at Appendix–I (Form-6) of the RFP. The Authority may approve or reject such proposal within 14 (fourteen) days of receipt thereof. In case the proposal is rejected, the Consultant may propose an alternative person for the Authority's consideration. In the event the Authority does not reject a proposal within 14 (fourteen) days of the date of receipt thereof under this Clause 4.3, it shall be deemed to have been approved by the Authority.
  - 4.4. Substitution of Key Personnel

The Authority expects all the Key Personnel specified in the Proposal to be available during implementation of the Agreement. The Authority will not consider any substitution of Key Personnel except under compelling circumstances beyond the control of the Consultant and the concerned Key Personnel. Such substitution shall be limited to not more than two Key Personnel subject to equally or better qualified and experienced personnel being provided to the satisfaction of the Authority. Without prejudice to the foregoing, substitution of one Key Personnel shall be permitted subject to reduction of remuneration equal to 10% (ten per cent) of the total remuneration specified for the Key Personnel who is proposed to be substituted. In case of a second substitution, such reduction shall be equal to 20% (twenty per cent) of the total remuneration specified for the Key Personnel who is proposed to be substituted.

4.5. Working hours, overtime, leave, etc.

The Personnel shall not be entitled to be paid for overtime nor to take paid sick leave or vacation leave except as specified in the Agreement, and the Consultant's remuneration shall be deemed to cover these items. All leave to be allowed to the Personnel is excluded from the person days of service set forth in Annex-2. Any taking of leave by any Personnel for a period exceeding 7 (seven) days shall be subject to the prior approval of the Authority, and the Consultant shall ensure that any absence on leave will not delay the progress and quality of the Services.

4.6. Team Leader and Project Manager



The person designated as the Team Leader of the Consultant's Personnel shall be responsible for the coordinated, timely and efficient functioning of the Personnel. In addition, the Consultant shall designate a suitable person as Project Manager (the "Project Manager") who shall be responsible for day to day performance of the Services.

- 5. Obligations of the Authority
  - 5.1. Assistance in clearances etc.

Unless otherwise specified in the Agreement, the Authority shall make best efforts to ensure that the Government shall:

- (b) provide the Consultant, its Personnel with work permits and such other documents as may be necessary to enable the Consultant, and its Personnel to perform the Services;
- (C) facilitate prompt clearance through customs of any property required for the Services; and
- (d) issue to officials, agents and representatives of the Government all such instructions as may be necessary or appropriate for the prompt and effective implementation of the Services.
- 5.2. Change in Applicable Law

If, after the date of this Agreement, there is any change in the Applicable Laws with respect to taxes and duties which increases or decreases the cost or reimbursable expenses incurred by the Consultant in performing the Services, by an amount exceeding 2% (two per cent) of the Agreement Value specified in Clause 6.1.2, then the remuneration and reimbursable expenses otherwise payable to the Consultant under this Agreement shall be increased or decreased accordingly by agreement between the Parties hereto, and corresponding adjustments shall be made to the aforesaid Agreement Value.

5.3. Payment

In consideration of the Services performed by the Consultant under this Agreement, the Authority shall make to the Consultant such payments and in such manner as is provided in Clause 6 of this Agreement.

- 6. Payment to the Consultant
  - 6.1. Cost estimates and Agreement Value
    - 6.1.1. An abstract of the cost of the Services payable to the Consultant is set forth in Annex-4 of the Agreement.
  - 6.2. Currency of payment



All payments shall be made in Indian Rupees. The Consultant shall be free to convert Rupees into any foreign currency as per Applicable Laws.

6.3. Mode of billing and payment

Billing and payments in respect of the Services shall be made as follows:

- (a) No mobilisation Advance shall be paid to the consultant. The payment shall be made as per the Annexure 5 Payment Schedule of the RFP.
- (b) The Consultant shall be paid for its services as per the Payment Schedule at Annex-5 of this Agreement, subject to the Consultant fulfilling the following conditions:
  - (iii) No payment shall be due for the next stage till the Consultant completes, to the satisfaction of the Authority, the work pertaining to the preceding stage.
  - (iv) The Authority shall pay to the Consultant, only the undisputed amount.
- (C) The Authority shall cause the payment due to the Consultant to be made within 45 (fortyfive) days after the receipt by the Authority of duly completed bills with necessary particulars (the "Due Date").
- (d) The final payment under this Clause shall be made only after the final report and a final statement, identified as such, shall have been submitted by the Consultant and approved as satisfactory by the Authority. The Services shall be deemed completed and finally accepted by the Authority and the final deliverable shall be deemed approved by the Authority as satisfactory upon expiry of 90 (ninety) days after receipt of the final deliverable by the Authority unless the Authority, within such 90 (ninety) day period, gives written notice to the Consultant specifying in detail, the deficiencies in the Services. The Consultant shall thereupon promptly make any necessary corrections and/or additions, and upon completion of such corrections or additions, the foregoing process shall be repeated. The Authority shall make the final payment upon acceptance or deemed acceptance of the final deliverable by the Authority.
- (e) Any amount which the Authority has paid or caused to be paid in excess of the amounts actually payable in accordance with the provisions of this Agreement shall be reimbursed by the Consultant to the Authority within 30 (thirty) days after receipt by the Consultant of notice thereof. Any such claim by the Authority for reimbursement must be made within 1 (one) year after receipt by the Authority of a final report in accordance with Clause 6.3 (d). Any delay by the Consultant in reimbursement by the due date shall attract simple interest @ 10% (ten per cent) per annum.
- (f) 30% (thirty per cent) of the Agreement Value has been earmarked as Final Payment to be made to the Consultant upon completion of Services. In the event of non-completion of Services within 2 (two) years of the Effective Date, the Final Payment shall not become due to the Consultant, save and except the costs incurred for meeting its reimbursable expenses during the period after expiry of 24 (twenty-four) months from the Effective Date, including travel costs and personnel costs, at the agreed rates.
- (g) All payments under this Agreement shall be made to the account of the Consultant as may be notified to the Authority by the Consultant.



- 7. Liquidated Damages and Penalties
  - 7.1. Performance Security
  - 7.1.1. The Authority shall retain by way of performance security (the "Performance Security"), 3% (three per cent) of all the amounts due and payable to the Consultant, to be appropriated against breach of this Agreement or for recovery of liquidated damages as specified in Clause 7.2. The balance remaining out of the Performance Security shall be returned to the Consultant at the end of 3 (three) months after the expiry of this Agreement pursuant to Clause 2.4 hereof. For the avoidance of doubt, the parties hereto expressly agree that in addition to appropriation of the amounts withheld hereunder, in the event of any default requiring the appropriation of further amounts comprising the Performance Security, the Authority may make deductions from any subsequent payments due and payable to the Consultant hereunder, as if it is appropriating the Performance Security in accordance with the provisions of this Agreement.
  - 7.1.2. The Consultant may, in lieu of retention of the amounts as referred to in Clause 7.1.1 above, furnish a Bank Guarantee substantially in the form specified at Annex-6 of this Agreement.
    - 7.2. Liquidated Damages
  - 7.2.1. Liquidated Damages for error/variation

In case any error or variation or plagiarism is detected in the data, data analysis or reports, submitted by the Consultant and such error or variation is the result of negligence or lack of due diligence on the part of the Consultant, the consequential damages thereof shall be quantified by the Authority in a reasonable manner and recovered from the Consultant by way of deemed liquidated damages, subject to a maximum of 10% (ten per cent) of the Agreement Value.

7.2.2. Liquidated Damages for delay

In case of delay in completion of Services, liquidated damages not exceeding an amount equal to 1% (one per cent) of the Agreement Value per week, subject to a maximum of 10% (ten per cent) of the Agreement Value will be imposed and shall be recovered by appropriation from the Performance Security or otherwise. However, in case of delay due to reasons beyond the control of the Consultant, suitable extension of time shall be granted.

7.2.3. Encashment and appropriation of Performance Security

The Authority shall have the right to invoke and appropriate the proceeds of the Performance Security, in whole or in part, without notice to the Consultant in the event of breach of this Agreement or for recovery of liquidated damages specified in this Clause 7.2.

7.3. Penalty for deficiency in Services

In addition to the liquidated damages not amounting to penalty, as specified in Clause 7.2, warning may be issued to the Consultant for minor deficiencies on its part. In the case of significant deficiencies in Services causing adverse effect on the Project or on the reputation of the Authority, other penal action including debarring for a specified period may also be initiated as per policy of the Authority.



### 8. Fairness and Good Faith

8.1. Good Faith

The Parties undertake to act in good faith with respect to each other's rights under this Agreement and to adopt all reasonable measures to ensure the realisation of the objectives of this Agreement.

8.2. Operation of the Agreement

The Parties recognise that it is impractical in this Agreement to provide for every contingency which may arise during the life of the Agreement, and the Parties hereby agree that it is their intention that this Agreement shall operate fairly as between them, and without detriment to the interest of either of them, and that, if during the term of this Agreement either Party believes that this Agreement is operating unfairly, the Parties will use their best efforts to agree on such action as may be necessary to remove the cause or causes of such unfairness, but failure to agree on any action pursuant to this Clause shall not give rise to a dispute subject to arbitration in accordance with Clause 9 hereof.

### 9. Settlement of Disputes

9.1. Amicable settlement

The Parties shall use their best efforts to settle amicably all disputes arising out of or in connection with this Agreement or the interpretation thereof.

- 9.2. Dispute resolution
- 9.2.1. Any dispute, difference or controversy of whatever nature howsoever arising under or out of or in relation to this Agreement (including its interpretation) between the Parties, and so notified in writing by either Party to the other Party (the "Dispute") shall, in the first instance, be attempted to be resolved amicably in accordance with the conciliation procedure set forth in Clause 9.3.
- 9.2.2. The Parties agree to use their best efforts for resolving all Disputes arising under or in respect of this Agreement promptly, equitably and in good faith, and further agree to provide each other with reasonable access during normal business hours to all non-privileged records, information and data pertaining to any Dispute.
  - 9.3. Conciliation

In the event of any Dispute between the Parties, either Party may call upon CEO, NITI Aayog and the Chairman of the Board of Directors of the Consultant or a substitute thereof for amicable settlement, and upon such reference, the said persons shall meet no later than 10 (ten) days from the date of reference to discuss and attempt to amicably resolve the Dispute. If such meeting does not take place within the 10 (ten) day period or the Dispute is not amicably settled within 15 (fifteen) days of the meeting or the Dispute is not resolved as evidenced by the signing of written terms of settlement within 30 (thirty) days of the notice in writing referred to in Clause 9.2.1 or such longer period as may be mutually agreed by the Parties, either Party may refer the Dispute to arbitration in accordance with the provisions of Clause 9.4.

9.4. Arbitration



- 9.4.1. Any Dispute which is not resolved amicably by conciliation, as provided in Clause 9.3, shall be finally decided by reference to arbitration by an Arbitral Tribunal appointed in accordance with Clause 9.4.2. Such arbitration shall be held in accordance with the Rules of Arbitration of the International Centre for Alternative Dispute Resolution, New Delhi (the "Rules"), or such other rules as may be mutually agreed by the Parties, and shall be subject to the provisions of the Arbitration and Conciliation Act,1996. The place of such arbitration shall be the capital of the State where the Authority has its headquarters and the language of arbitration proceedings shall be English.
- 9.4.2. There shall be a sole arbitrator whose appointment or an Arbitral Tribunal of three arbitrators, of whom each Party shall select one, and the third arbitrator shall be appointed by the two arbitrators so selected, and in the event of disagreement between the two arbitrators, the appointment<sup>23</sup> shall be made in accordance with the Rules.
- 9.4.3. The arbitrators shall make a reasoned award (the "Award"). Any Award made in any arbitration held pursuant to this Clause 9 shall be final and binding on the Parties as from the date it is made, and the Consultant and the Authority agree and undertake to carry out such Award without delay.
- 9.4.4. The Consultant and the Authority agree that an Award may be enforced against the Consultant and/or the Authority, as the case may be, and their respective assets wherever situated.
- 9.4.5. This Agreement and the rights and obligations of the Parties shall remain in full force and effect, pending the Award in any arbitration proceedings hereunder.

#### Schedule 3: Guidance Note on Conflict of Interest

(See <u>Clause 2.3.3</u>)

- 1. This Note further explains and illustrates the provisions of <u>Clause 2.3</u> of the RFP and shall be read together therewith in dealing with specific cases.
- 2. Consultants should be deemed to be in a conflict of interest situation if it can be reasonably concluded that their position in a business or their personal interest could improperly influence their judgment in the exercise of their duties. The process for selection of consultants should avoid both actual and perceived conflict of interest.
- 3. Conflict of interest may arise between the Authority and a consultant or between consultants and present or future contractors. Some of the situations that would involve conflict of interest are identified below:
  - (a) Authority and consultants:
    - (i) Potential consultant should not be privy to information from the Authority which is not available to others;
    - (ii) Potential consultant should not have defined the project when earlier working for the Authority;
    - (iii) Potential consultant should not have recently worked for the Authority overseeing the project.
  - (b) Consultants and contractors:
    - No consultant should have an ownership interest or a continuing business interest or an on-going relationship with a potential contractor save and except relationships restricted to project-specific and short-term assignments; or
    - (ii) no consultant should be involved in owning or operating entities resulting from the project; or
    - (iii) no consultant should bid for works arising from the project.

The participation of companies that may be involved as investors or consumers and officials of the Authority who have current or recent connections to the companies involved, therefore, needs to be avoided.

- 4. The normal way to identify conflicts of interest is through self-declaration by consultants. Where a conflict exists, which has not been declared, competing companies are likely to bring this to the notice of the Authority. All conflicts must be declared as and when the consultants become aware of them. The principle of *Uberrimae Fidei* will be applicable to the volutary disclosure of the applicant regarding conflict of interest which has to ensure the highest standard of good faith during the disclosure of all material facts that could influence the decision of the other party.
- 5. Another approach towards avoiding a conflict of interest is through the use of "Chinese walls" to avoid the flow of commercially sensitive information from one part of the consultant's company to another. This could help overcome the problem of availability of limited numbers of experts for the project.



However, in reality effective operation of "Chinese walls" may be a difficult proposition. As a general rule, larger companies will be more capable of adopting Chinese walls approach than smaller companies. Although, "Chinese walls" have been relatively common for many years, they are an increasingly discredited means of avoiding conflicts of interest and should be considered with caution. As a rule, "Chinese walls" should be considered as unacceptable and may be accepted only in exceptional cases upon full disclosure by a consultant coupled with provision of safeguards to the satisfaction of the Authority.

- 6. Another way to avoid conflicts of interest is through the appropriate grouping of tasks. For example, conflicts may arise if consultants drawing up the terms of reference or the proposed documentation are also eligible for the consequent assignment or project.
- 7. Another form of conflict of interest called "scope-creep" arises when consultants advocate either an unnecessary broadening of the terms of reference or make recommendations which are not in the best interests of the Authority but which will generate further work for the consultants. Some forms of contractual arrangements are more likely to lead to scope-creep. For example, lump-sum contracts provide fewer incentives for this, while time and material contracts provide built-in incentives for consultants to extend the length of their assignment.
- 8. Every project contains potential conflicts of interest. Consultants should not only avoid any conflict of interest but should also report any present/ potential conflict of interest to the Authority at the earliest. Officials of the Authority involved in development of a project shall be responsible for identifying and resolving any conflicts of interest. It should be ensured that safeguards are in place to preserve fair and open competition and measures should be taken to eliminate any conflict of interest arising at any stage in the process.
- 9. Without limiting the generality of the above and Section 2.3, an Applicant shall be deemed to have a Conflict of Interest affecting the Selection Process, if:
  - (a) Conflicting Associations:
    - directly or indirectly controls, is controlled by or is under common control with another Applicant; or
    - receives or has received any direct or indirect subsidy/ financial stake from another Applicant; or
    - has the same correspondence address or same legal representative/ agent as another applicant for purposes of this proposal; or
    - has a relationship with another applicant, directly or through common third parties, that puts it in a position to have access to information about or influence the Proposal of another applicant or influence the decisions of the Authority regarding this Procurement Process; or
  - (b) Unfair Competitive Advantage and Conflicting Activities: had (or any of its Affiliates) been engaged by the Authority to provide goods, works, or services for a project, shall be disqualified from providing consulting services resulting from or directly related to those goods, works, or services. Conversely, a firm (or any of its Affiliates) hired to provide consulting services for the preparation or implementation of a project shall be disqualified from subsequently providing goods or works or services resulting from or directly related to the consulting services for such preparation or implementation or



- (c) Conflicting Assignments: would (including its Experts or any of its Affiliates) be or are providing consultancy services in another assignment for the same or another Authority that, by its nature, may conflict with this assignment.
- (d) Commissions and Gratuities: The Applicant shall disclose any commissions or fees that may have been paid or are to be paid to agents, representatives, or commission agents concerning the selection process or execution and performance of the resulting Contract. The information disclosed must include the name and address of the agent, representative, or commission agent, the amount and currency, and the purpose of the commission or fee.; or
- (e) Conflicting Relationships: has close business/ family relationship with a staff of the Authority who are/ would be directly/ indirectly involved in any of the following activities:
  - i. Preparation of the RFP document or ToR of the procurement process
  - ii. Evaluation of Proposals or Award of Contract, or
  - iii. Implementation/supervision of the resulting contract
- (f) For purposes of this RFP, Associate means, in relation to the Applicant, a person who controls, is controlled by, or is under the common control with such Applicant (the "Associate"). As used in this definition, the expression "control" means, with respect to a person which is a company or corporation, the ownership, directly or indirectly, of more than 50% (fifty per cent) of the voting shares of such person, and with respect to a person which is not a company or corporation, the power to direct the management and policies of such person by operation of law or by contract.
- (g) Conflict of interest, for the process of determination, shall include presence of conflict, potential or actual, during one year preceding the last date of bid submission and shall include the factual conspectus related to the personnel specifically indicated as the lead professional of the project team termed as Team Lead/Principal Investigator.
