Subject: Response to queries received on the Request for Proposal (RFP) for the evaluation of Atal Bhujal Yojana by DMEO, NITI Aayog – reg.

Following the publication of the RFP on 8th September 2025 and the pre-proposal conference on 23rd September 2025, queries received on the RFPs were examined and responses to such queries are given below. The general clarification is in the following paragraphs and specific query-wise response is in Table 1.

2. Some general clarification are given below:

a. Scoring of relevant experience of the applicant:

- i. With respect to the Scoring Criteria mentioned in Clause 4.1.3 (1 (a) and 1 (c)), it is clarified that while considering the 10 eligible assignments the relevant experience of all the members of the consortium including the Lead Member would be considered for scoring. However, the Lead Member must fulfill a minimum of 40 percent of the total number of eligible assignments submitted by the Consortium (details to be filled at Appendix I Form 8 of the RFP), and the remaining can come from one or more of the other consortium members.
- ii. To avoid ambiguity, the Scoring Criteria mentioned in Clause 4.1.3 (1 (b)), in case of a consortium, will consider the annual revenue of the Lead Member only (details to be filled at Appendix I Form 5 of the RFP) for scoring.
- **b. Number of Consortium Members:** It is also clarified that for consortium, a maximum of four (4) consortium members (including the Lead Member) are allowed.
- 3. All the terms and conditions of the RFP shall remain unaffected.

However, slightly different criteria for Madhya Pradesh and Maharashtra are mentioned in pg 45 (majority classified as semi-critical and safe), and pg 60 (excluded all assessment units classified as safe). Which one of the criteria is it	It is a typo error. In Madhya Pradesh, since none of the assessment units falls under the critical and over-exploited category, assessment units falling under safe and semi-critical categories were considered for sampling. Among these, all the assessment units of three districts were categorized as safe. These three districts were not considered for the sampling and randomization was applied in the remaining districts. Whereas, in Maharashtra most of the assessment units falls under the safe and semi-critical categories. Randomization was applied in these units and two districts were selected.
7.	Clause 6 of Schedule I (Terms of Reference)	Sampling of Blocks: pg 45 mentions that the blocks need to be classified into the 4 groundwater categories. However, the table mentions one 'aspirational block' to be covered under each district if available. Thereby, in addition to the 'aspirational block' criteria, should the groundwater classification also be a criteria for sampling?	Please refer to Clause 6 of the Terms of Reference: Within each district, blocks should be classified into the four groundwater categories based on the degree of exploitation. Aspirational blocks, when included, must be selected from within these categories and are not to be treated as a separate sampling criterion
